SUBJECT: **BID NO. F2025118 - ANNUAL CONTRACT FOR INMATE UNIFORMS - SHERIFF'S OFFICE**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court reject all bids for Bid No. F2025118, Annual Contract for Inmate Uniforms, and grant permission to rebid with revised specifications.

**BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Three hundred eighty-one (381) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on April 16, 2025 was attended by four (4) vendors as well as representatives from the Sheriff's Office and Purchasing. Six (6) bids and four (4) no-bids were received.

After review of the submitted bids, it was determined that the vendors did not meet the minimum specifications because two (2) vendors did not bid on all items as required, one (1) vendor did not send samples as required, or vendor samples received did not meet specifications for fabric requirements, tag placement, or incorrect imprinting.

Therefore, it is the joint recommendation of the Sheriff's Office and Purchasing that the Commissioners Court reject all bids received for Bid No. F2025118, Annual Contract for Inmate Uniforms, and grant permission to rebid with revised specifications.
