COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider the submission of the Grant Year (GY) 2025 Urban Area Security Initiative Program Grant Application and Resolution to the Office of the Governor, Homeland Security Division, for the Cybersecurity Program Enhancement project.

BACKGROUND

The Office of the Governor’s Homeland Security Grant Program provides UASI funding to assist states and urban areas in enhancing the ability to prevent, protect against, respond to, and recover from terrorist attacks, major disasters, and other emergencies. This funding directly strengthens state and local preparedness for a range of potential threats.

Since 2004, Tarrant County has applied for and received funding through this grant program to support various projects related to emergency management.

If approved, GY 2025 UASI funds will be used to procure an Identity and Access Management (IAM) system to enhance the County’s cybersecurity infrastructure. The IAM system will implement structured access controls, restricting access to data and applications based on user credentials. The system will also incorporate location and device tracking to mitigate potential intrusions into Tarrant County’s systems. Additionally, funding will support the continued use of monitoring software and provide cybersecurity training focused on identifying and responding to cyber-attacks such as phishing emails.

The grant request is for \$125,000.00 to support the Cybersecurity Program Enhancement project. The performance period for this grant is from January 1, 2026, to December 31, 2026.

The Budget and Risk Management Office has reviewed the budget for this application.

FISCAL IMPACT

The grant request is for \$125,000. This grant does not require match or operating subsidy. Indirect costs are allowed and have been added to the program budget.
