**SUBJECT: BID NO. F2025133 - ANNUAL CONTRACT FOR TRAFFIC PAINT -

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award Bid No. F2025133, Annual Contract for Traffic Paint, for Transportation Services, to the following vendors at the per unit price:

Primary Greenville Enterprises LLC
Secondary LBS Enterprises, LLC d/b/a Allstates Coatings Company
Alternate Ennis-Flint, Inc.

BACKGROUND

Notice of the County’s intent to bid was advertised in a local newspaper, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Six hundred fifty-six (656) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. No vendors attended the pre-bid conference held on April 9, 2025. Six (6) bids and six (6) no-bids were received.

Bids were evaluated by Transportation Services and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

The term of the contract is twelve (12) months, effective August 27, 2025, with two (2) options for renewal periods of twelve (12) months each.

The purpose of this contract is to maintain the striping on unincorporated roadways, in addition to the parking lot striping for Tarrant County facilities and parking garages.

Therefore, it is the joint recommendation of Transportation Services and Purchasing that Bid No. F2025133, Annual Contract for Traffic Paint, be awarded to the vendors listed above at the per unit price.

FISCAL IMPACT

Expenses for the last twelve (12) months were \$80,468.00. Funding is available in account 26100-2025 Road and Bridge/6840300000 Sign Shop/523011 Parts and Supplies.

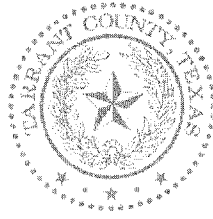

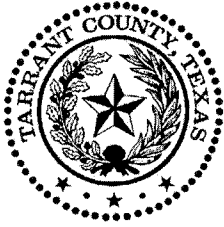
