It is requested that the Commissioners Court approve a grant agreement between Tarrant County and Finding Me Academy Global to provide support services to the residents of Tarrant County.

BACKGROUND

Commissioner, Precinct 2's Community Organization Program was created to support proactive and hard-working organizations in Tarrant County. The program targets organizations whose goals are to better the community and help citizens in need. Some examples of related initiatives may include Youth Programs, Public Health (Physical and Mental), Housing, Education and Criminal Justice Reform.

Finding Me Academy Global has been selected to receive Precinct 2 Community Outreach Program funds to support its Conflict Resolution, Life Skills, and Workforce Development Program.

This program serves Tarrant County students in Grades 3–12 and includes academic enrichment, college and career readiness instruction, conflict resolution, and workplace preparation. Participants also receive training in public speaking, financial literacy, and personal development. Program outcomes are measured using pre- and post-assessments.

If awarded, funding in the amount of \$10,000.00 will be used to support curriculum materials, supplies, and delivery of instructional programming for the Conflict Resolution, Life Skills, and Workforce Development Program.

This grant agreement has been approved as to form by the Criminal District Attorney's Office.

WHEREAS, **FINDING ME ACADEMY GLOBAL** is a nonprofit youth development organization dedicated to equipping students with critical life and workforce skills through inclusive, academic-based programming. **FINDING ME ACADEMY GLOBAL'S** Conflict Resolution, Life Skills, and Workforce Development Program serves students in Tarrant County by fostering communication, leadership, career readiness, and personal growth; and

WHEREAS, the Tarrant County Commissioners Court hereby finds that the program provided by **FINDING ME ACADEMY GLOBAL** benefits the residents of Tarrant County, Texas, and hereby declares that this **Agreement** is one of a professional service;

NOW, THEREFORE, this **Agreement** is made and entered into this 3rd day of June 2025, by and between **FINDING ME ACADEMY GLOBAL** acting by and through its duly authorized agent, and **TARRANT COUNTY, TEXAS ("COUNTY")**, acting by and through its County Judge.

FINDING ME ACADEMY GLOBAL and the **COUNTY** agree as follows:

1. **FINDING ME ACADEMY GLOBAL** provide the Conflict Resolution, Life Skills, and Workforce Development Program at no cost to students. Programming will include academic and life skills instruction, college and career readiness workshops, and training in workplace preparedness and interpersonal communication. The program anticipates serving approximately 160 students during the contract term, with services targeted toward youth in grades 3–12 in Tarrant County.

2. **COUNTY**, for and in consideration of the services provided, agrees to pay to **FINDING ME ACADEMY GLOBAL** a lump sum payment of **\$10,000.00** for services rendered to the residents of Tarrant County, Texas for the fiscal year beginning October 1, 2024, and ending September 30, 2025.

3. **TO THE EXTENT ALLOWED BY TEXAS LAW, FINDING ME ACADEMY GLOBAL HEREBY AGREES TO INDEMNIFY AND HOLD HARMLESS COUNTY, ITS OFFICERS, AGENTS, OFFICIALS, AND EMPLOYEES FROM ANY LOSS, DAMAGE, INJURY OR CLAIM ARISING FROM THE NEGLIGENT OPERATION OF ITS PROGRAM. SAID INDEMNIFICATION WILL INCLUDE, BUT NOT BE LIMITED TO, ALL AMOUNTS OF ALL CLAIMS, ATTORNEYS' FEES, AND COSTS OF COURT.**

Nothing contained in this **Agreement** shall be deemed or construed by the parties hereto, nor by any third party, as creating the relationship of principal and agent, partnership, joint enterprise, common enterprise, joint venture, joint owners, or joint tenants between the parties. The parties hereby declare and acknowledge that the relationship existing is one of independent contractor. This **Agreement** does not and shall not be construed to entitle either party or any of their respective employees or officials, if applicable, to any benefit, privilege or other amenities of employment from the other party.

5. This **Agreement** shall not be interpreted to inure to the benefit of a third party not a party to this **Agreement**. This **Agreement** may not be interpreted to waive any statutory or common law defense, immunity, including governmental and sovereign immunity, or any limitation of liability, responsibility, or damage of any party to this **Agreement**, party's agent, or party's employee, otherwise provided by law.
6. The parties to this **Agreement** will not sell, assign, transfer or convey any benefits or obligations of this **Agreement** in whole or part without the prior written consent of both parties.
7. If any one or more of the provisions contained in this **Agreement**, for any reason, be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability will not affect any other provision of this **Agreement**.
8. This **Agreement** constitutes the entire agreement between the parties, and any and all prior negotiations are merged into this **Agreement**. Any amendment, change, or addition to this **Agreement** shall be made only in writing and signed by both parties.
9. This **Agreement** will be governed by and construed according to the laws of the State of Texas. Venue for any action or claim arising from this **Agreement** will be in Tarrant County, Texas, as to state court actions, and the United States District Court for the Northern District of Texas, as to federal court actions.
10. In providing the services required by this **Agreement**, **FINDING ME ACADEMY GLOBAL** must observe and comply with all applicable federal, state, and local statutes, ordinances, rules, and regulations, including, without limitation, workers' compensation laws, minimum and maximum salary and wage statutes and regulations, and non-discrimination laws and regulations. **FINDING ME ACADEMY GLOBAL** shall be responsible for ensuring its compliance with any laws and regulations applicable to its business, including maintaining any necessary licenses and permits.
