**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court consider seventy (70) separate Motor Vehicle License Agreements between Tarrant County, d/b/a Tarrant County Tax Assessor-Collector and Motor Vehicle Dealers, Contract Sales, Cities and School Districts to process motor vehicle registrations.

**BACKGROUND**

The Texas Department of Motor Vehicles (TXDMV) uses a program and inventory system known as WebDealer to process titles and motor vehicle registrations. These agreements allow the Tarrant County Tax Assessor-Collector's Office to provide the different entities as described in the attached list with access to the WebDealer system as well as supplies to efficiently process titles and registrations remotely, saving time and creating more efficiencies for the Tarrant County Tax Office.

The terms of the contracts are from September 1, 2024 through August 31, 2026.
