Attachment A

1. *Various items related to Fort Worth history, donated by Dalton Hoffman (2024-007-503; 2024-009-503; 2024-032-503; 2024-035-503)*

Donation materials include digital scans of photographs, postcards, a map, and a newspaper all related to Fort Worth history and dating from 1876-1942. Physical materials donated include audio records from the Light Crust Doughboys, newspaper advertisement clippings from local businesses that have since closed, newspaper clippings about local individuals and events, publications from the American Flyers Airline Corporation and Cattle Raisers' Association, various titles of local newspapers, postcards, posters for local amusements and businesses, books related to Tarrant County history, real estate brochures, Burrus Mill promotional items, certificates and reports from various companies and city and county offices, city directories, maps, correspondence, ledgers from various businesses, and various artifacts like buttons, ribbons, and tokens from the Texas and Southwestern Cattle Raisers Association.

2. *Various items related to Tarrant County history, donated by Jamie Sheppard (2024-025-656)*

Materials donated include mostly photographs and postcards showing local scenes, businesses, and people. These images show the daily life of an earlier time, including automobiles, clothing, buildings, and businesses that may no longer exist. Also included are Northeast Tarrant County Chamber of Commerce marbles, newspaper advertisement clippings from local businesses, promotional items from various businesses and colleges including T&P Railway and Brantley-Draughon Business College.

3. *Maps and documents from the Tarrant County Elections Office, donated by the Tarrant County Elections Office (2024-031-468)*

This donation includes maps showing precinct lines for various offices from the 1960s through 2015. Also included are documents related to district changes, boundary information, and election guidelines. All of these materials show the evolution of the election precinct maps for Tarrant County. With this donation, three map cases were transferred from the Elections Office to the Archives.

4. *Photographs and other items related to Fort Worth family, donated by Kathy Fowler (2024-033-088; 2025-004-088)*

This donation is a large collection consisting mostly of photographs of a family that settled in Fort Worth and were connected with many notable people and businesses. The photographs and some documents and artifacts represent the history of local schools, organizations, and businesses like the Fort Worth Ice House, as well as show locations that are not well represented in the Archives, such as Saginaw and Everman.

5. *Documentation of the Handley Neighborhood Association, donated by Paul Kerpoie (2024-034-132; 2025-011-132)*

Donated materials include Handley Neighborhood Association administrative records as well as research on the Handley community's history in both hard copy and digital files. These records tell the history of both the neighborhood itself as well as the history of the neighborhood

association which worked to establish a historic business district and support preservation efforts.

6. Fort Worth Cats baseball programs, donated by Derek Sutter (2024-036-111)

Materials donated include Fort Worth Cats souvenir programs, scorecard, and team poster dated between 2004 and 2013. These materials add to the Cats memorabilia held in the Archives, and represent the more recent history of the team, and Fort Worth's minor league baseball history.

7. 1928 Fort Worth Directory, donated by the Arlington Historical Society (2024-037-283)

This Fort Worth Directory from 1928 fills in a gap in the series of directories held in the collections. City directories are useful tools for researching individuals, businesses, buildings, and the growth and changes that occur within cities.

8. Tarrant County Historical Society Directory, donated by Harry Max Hill (2024-038-346)

This membership directory for the Tarrant County Historical Society, was donated to add to the Tarrant County Historical Society Collection. This directory shows members, positions held, and other pertinent information regarding the society for 2024-2025.

9. Various documents and records related to Tarrant County history, donated by the Tarrant County Transportation Department (2024-040-224)

Materials donated include land abstracts for land purchased by Tarrant County, documents and a map related to levee construction, and documents and maps related to the original Tarrant County school district. These materials detail important aspects of Tarrant County government, property ownership, and the history of many schools that no longer exist.

10. Wedgwood newspapers, donated by the Wedgwood Historical Association (2024-041-721)

Copies of the *Wedgwood Village Thrifty Shopper* newspaper were added to the existing Wedgwood Historical Association Collection, which is made up of mostly *Wedgwood Shopping News* newspapers. These additional papers show another aspect of the Wedgwood neighborhood history.

11. 2016 Fort Worth Symphony Orchestra strike materials, donated by Adrienne Clay (2024-042-095)

Donation includes ephemera and memorabilia from the 2016 Fort Worth Symphony Orchestra strike, including a t-shirt, button, rubber bracelet, flyers, and document about the negotiations. These materials highlight a small piece of the Fort Worth Symphony Orchestra's history that might not otherwise be remembered.

12. Ledgers for Eules Nursery, donated by Weldon Cannon (2024-043-232)

Materials in this donation were added to the Weldon G. Cannon Collection which focuses on the history of Eules. Materials donated include business ledgers and records for the Eules Nursery and the Ross Cannon Real Estate businesses, land abstract for the property where the Eules

Nurse / Eules Lumber Company were situated, and a document on the history of commercial horticulture in Euless.

13. Scrapbook and photo album on Executive Women International, Fort Worth Chapter, donated by Janet S. Minke (2024-045-137)

Items donated are a scrapbook and photo album covering the year that the donor acted as president of the Executive Women International, Fort Worth Chapter, 1989-1990. The materials show the activities of the organization, photos of members, and information about meetings. The chapter disbanded sometime in the 1990s or early 2000s, and these items give a small glimpse into the chapter's history.

14. Photographs of Fort Worth brewery labor union members, donated by Linda Berger (2024-047-143)

Donation includes two photographs from around 1936, one shows members of the Brewery Workers Local Union Number 108 with a Golden Lager Beer sign, and the other shows Walter Bob Berger Sr. in front of a Superior Brewing Company truck. These photographs show the prevalence and importance of unions in Fort Worth's history, while also showing a snapshot of the period.

15. Materials related to the Tax Assessor-Collector's Office, donated by the Tarrant County Tax Assessor-Collector's Office (2024-048-114)

Materials include tax roll statements and related correspondence and records, requests for tax exemption from various institutions, plans for proposed right of way projects on IH-20 and IH-30, plat maps showing Fresh Water District, Tarrant County map showing voting precincts and notable sites from 1895, reproduction photos of past Tax Assessor-Collectors, and newspaper clippings covering license plates and vehicle registration tax.

16. President Carter poster, donated by Theresa Berglund (2025-001-737)

Item donated is a poster notifying of the visit of President Jimmy Carter to the Fort Worth Stockyards in 1980, during his reelection campaign. This item highlights both national and local history.

17. Green-Hess family materials, donated by First United Methodist Church Fort Worth Archives (2025-005-150)

Donated materials include records and photographs that document the personal and professional lives of the Green-Hess family from the 1890s to the 1960s. The early Greens settled in Fort Worth in 1909, and were active in the community, including William Marvin Green becoming Fort Worth Superintendent of Public Schools in 1931.

18. Tarrant County AgriLife materials, donated by the Tarrant County AgriLife Extension Office (2025-006-467)

Materials donated include photographs, publications, documents, and more related to the history of the Tarrant County AgriLife Extension program. These materials highlight various

initiatives and events run by the Extension office and their connection to the community. Also included are educational materials and personal photographs from Extension members.

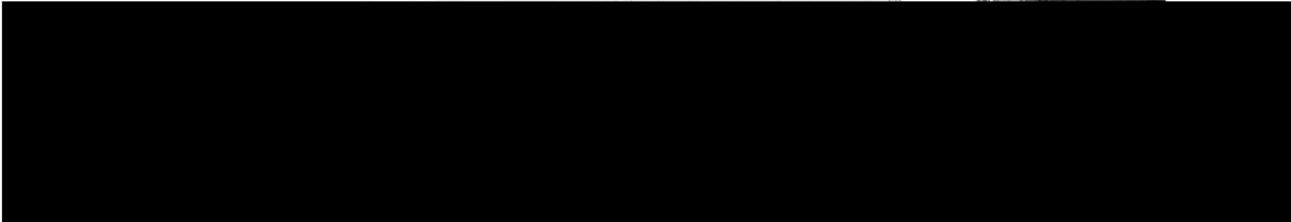
