COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of RFP No. F2024096, Annual Contract for Payroll Services and Temporary Labor, for the first optional twelve (12) month period, at the same contract terms.

BACKGROUND

On August 6, 2024, the Commissioners Court, through Court Order #143585, awarded RFP No. F2024096, Annual Contract for Payroll Services and Temporary Labor, for Elections Administration, to the following vendors:

Primary Smith Temporaries Inc. d/b/a CornerStone Staffing

Secondary 22nd Century Technologies, Inc.

Alternate 1 Ad-A-Staff Inc. Alternate 2 MMC Group, L.P.

The awards were based upon evaluation criteria set forth in the RFP specifications and contained options to renew for three (3) additional twelve (12) month periods.

The contract provides the Auditor's Office payroll team relief from the large volume of work required to process payroll payments for temporary workers hired during the various election cycles, provides personnel who have been vetted and background checked, and ensures all legal requirements are met regarding employment for temporary employees.

The vendors notified Purchasing in writing that they will extend the same contract terms through August 31, 2026. Elections Administration notified Purchasing in writing that they are pleased with the vendors and want to renew.

Therefore, it is the joint recommendation of Elections Administration and Purchasing that the Commissioners Court approve renewal of RFP No. F2024096, Annual Contract for Payroll Services and Temporary Labor, for another twelve (12) month period.
