**SUBJECT: CONSIDERATION OF REVISIONS TO THE TARRANT COUNTY PUBLIC
HEALTH ENVIRONMENTAL HEALTH FEE SCHEDULE**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve revisions to the Tarrant County Public Health Environmental Health (EH) Fee Schedule.

BACKGROUND

The Tarrant County Public Health Department (TCPH) Environmental Health division provides regulatory inspections of food establishments and public/semi-public swimming pools in unincorporated areas of the county, as well as in 30 contracted cities (including Dallas Fort Worth International Airport). These inspections cover businesses and vendors that offer food for public consumption or operate public/semi-public swimming pools.

On August 1, 2023, through Court Order #141339, the Commissioners Court adopted a revised County Order regulating food establishments, which included an updated fee schedule.

During the 89th Legislative Session, the State of Texas enacted Senate Bill 1008, revising Texas Health & Safety Code Chapter 437. The revisions require all food establishment fees to align with the Texas Department of State Health Services (TX DSHS) food establishment fee schedule. The legislation also permits counties to set a higher fee, provided it does not exceed 120% of the TX DSHS schedule.

In line with this authority, TCPH EH proposes adding a late fee for permitted public/semi-public swimming pools in addition to the updated food establishment fees.

If approved, the attached revised TCPH EH fee schedule will take effect September 1, 2025.

This item has been approved as to form by the District Attorney's Office.

FISCAL IMPACT

All revenue will be placed in the 22300 Consumer Health Fund.
