SUBJECT: CONSIDERATION OF AN ORDER DESIGNATING THE FREQUENCY IN WHICH THE COMMISSIONERS COURT WILL CONVENE IN REGULAR TERM DURING FISCAL YEAR 2026

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider the attached proposed Order designating the frequency in which the Commissioners Court shall convene in the regular term during FY 2026.

BACKGROUND

Local Government Code Section 81.005(a) states, "the commissioners court by order shall designate a day of the week on which the court shall convene in a regular term each month during the next fiscal year" and sets at minimum a quarterly meeting requirement. However, Local Government Code Section 81.005(h) grants a commissioners court discretion to "designate a day of the week on which the court shall convene in a regular term each month other than the day of the week designated under Subsection (a)."

The accompanying Order proposes that beginning October 1, 2025, the Commissioners Court shall convene on the second Tuesday of each month at 10:00 a.m. in the Commissioners Courtroom, Tarrant County Administration Building, 100 East Weatherford Street, 5th Floor, Fort Worth, Texas 76196. An exception is made for December 2025, when the Court will convene on the third Tuesday of the month at the same time and place, and for August and September 2026, when the Court will convene on the first and third Tuesday of each month at the same time and place.

The Criminal District Attorney's Office has approved this Order as to form.

WHEREAS, in accordance with Section 81.005(a) (Terms of Court, Meetings), Local Government Code, the Tarrant County Commissioners Court by this Order designates the second Tuesday of each month at 10:00 a.m., in the Commissioners' Courtroom, Tarrant County Administration Building, 100 East Weatherford Street, 5th Floor, Fort Worth, Texas 76196, as the frequency, day of the week, time, and location on and at which the Court shall convene in regular term during Fiscal Year 2026; and

WHEREAS, only for the month of December 2025, the third Tuesday of that month is designated as the meeting date for the Tarrant County Commissioners Court's regular term at the same time and place as described above; and

WHEREAS, only for the months of August and September 2026, the first and third Tuesdays of those months are designated as the meeting dates for the Tarrant County Commissioners Court's regular term at the same time and place as described above; and

IT IS THEREFORE, ORDERED that the Tarrant County Commissioners Court by this Order hereby designates the second Tuesday of each month, with the exception of December 2025, August 2026, and September 2026, at 10:00 a.m., in the Commissioners' Courtroom, Tarrant County Administration Building, 100 East Weatherford Street, 5th Floor, Fort Worth, Texas 76196, as the frequency, day of the week, time and location on and at which the Court will convene in regular term during Fiscal Year 2026, beginning October 1, 2025. For December 2025 only, the Court will convene on the third Tuesday of that month at the same time and place. For August and September 2026 only, the Court will convene on the first and third Tuesday of those months at the same time and place.

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider the attached proposed Order designating the frequency in which the Commissioners Court shall convene in the regular term during FY 2026.

BACKGROUND

Local Government Code Section 81.005(a) states, "the commissioners court by order shall designate a day of the week on which the court shall convene in a regular term each month during the next fiscal year" and sets at minimum a quarterly meeting requirement. However, Local Government Code Section 81.005(h) grants a commissioners court discretion to "designate a day of the week on which the court shall convene in a regular term each month other than the day of the week designated under Subsection (a)."

The accompanying Order proposes that beginning October 1, 2025, the Commissioners Court shall convene on the second Tuesday of each month at 10:00 a.m. in the Commissioners Courtroom, Tarrant County Administration Building, 100 East Weatherford Street, 5th Floor, Fort Worth, Texas 76196. An exception is made for December 2025, when the Court will convene on the third Tuesday of the month at the same time and place, and for August and September 2026, when the Court will convene on the first and third Tuesday of each month at the same time and place.

WHEREAS, only for the months of August and September 2026, the first and third Tuesdays of those months are designated as the meeting dates for the Tarrant County Commissioners Court's regular term at the same time and place as described above; and

IT IS THEREFORE, ORDERED that the Tarrant County Commissioners Court by this Order hereby designates the second Tuesday of each month, with the exception of December 2025, August 2026, and September 2026, at 10:00 a.m., in the Commissioners' Courtroom, Tarrant County Administration Building, 100 East Weatherford Street, 5th Floor, Fort Worth, Texas 76196, as the frequency, day of the week, time and location on and at which the Court will convene in regular term during Fiscal Year 2026, beginning October 1, 2025. For December 2025 only, the Court will convene on the third Tuesday of that month at the same time and place. For August and September 2026 only, the Court will convene on the first and third Tuesday of those months at the same time and place.
