COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider the acceptance of GY 2024 Urban Area Security Initiative Homeland Security Grant Program grant award from the Office of the Governor (OOG), Homeland Security Division, to support the Tarrant County Emergency Management Enhancement Project.

BACKGROUND

The Office of the Governor is responsible for coordinating homeland security initiatives such as the UASI Grant Program. The UASI is awarded to states and urban areas to enhance the ability to prevent, protect against, respond to, and recover from terrorist attacks.

Since 2004, Tarrant County has applied for and received funding through the UASI grant program to support various projects related to emergency management.

The Emergency Management Enhancement Project was established in 2008 to support the salaries of one (1) full-time planning position. The planner assists with resource identification, updating multiple plans, and other emergency management-related activities. Additionally, the funds cover costs related to planning such as registration fees and travel to conferences, trainings, and exercises.

On March 19, 2024, the Commissioners Court, through Court Order #142811, approve the submission of GY 2024 UASI grant application to the OOG, Homeland Security Division, to support the Tarrant County Emergency Management Enhancement Project in the amount of \$189,527.42

With approval, grant funding in the amount of \$125,000.00 will be used to support the salary of one (1) full-time planning position. The planner will assist with emergency management-related activities as mentioned above.

The grant period is from January 1, 2025 through December 31, 2025. This is a one (1) year funding cycle.
