SUBJECT: **CONSIDERATION OF THE PROGRAM YEAR 2024 HOME-DELIVERED MEALS GRANT AFFIDAVIT FOR MEALS ON WHEELS OF TARRANT COUNTY**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider the Program Year 2024 Texas Feeding Texans: Home-Delivered Meals (HDM) Grant Affidavit for Meals on Wheels of Tarrant County (MOWTC), certifying that Tarrant County has successfully issued a required local grant match payment to MOWTC.

BACKGROUND

In October 2023, MOWTC applied for the Program Year (PY) 2024 HDM Grant from the Texas Department of Agriculture. The grant required a local grant match from Tarrant County in an amount determined by the Texas Department of Agriculture. Further, the grant required the County to review MOWTC's accounting system.

On October 17, 2023, the Commissioners Court, through Court Order #141935, approved the grant agreement and resolution supporting MOWTC's HDM grant application. Upon approval, the County was required to provide MOWTC with funding in the amount of \$86,876.25 to be used between October 1, 2023 through September 30, 2024. As a result of the local match provided by Tarrant County, MOWTC was eligible to receive up to \$989,419.39 in HDM Grant funding from the Texas Department of Agriculture.

If approved, Tarrant County will provide the signed affidavit to MOWTC, certifying that the County successfully issued a grant payment to MOWTC in the amount of \$86,876.25 as outlined in the original resolution.

The Criminal District Attorney's Office has approved the affidavit as to form.

FISCAL IMPACT

This grant award to Meals on Wheels from the Texas Department of Agriculture is for \$989,419.39. Tarrant County's local match was \$86,876.25.

The local match was made using funds located in account:

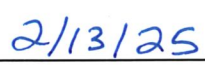
