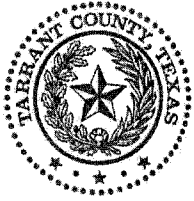
Tarrant County received notification of the vendor name change from Bernhard MCC, LLC to ENFRA MCC, LLC effective May 1, 2025.

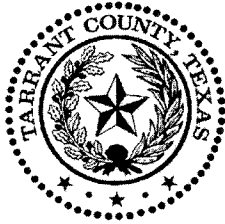
