COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award Bid No. F2025127, Annual Contract for Pistols, Countywide, to the following vendors at the per unit price:

Primary Primary Arms LLC
Secondary GT Distributors, Inc.
Alternate Kiesler Police Supply Inc.

BACKGROUND

Notice of the County’s intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Three hundred twenty-seven (327) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on April 23, 2025 was attended on one (1) vendor as well as representatives from the Sheriff’s Office and Purchasing. Four (4) bids and four (4) no-bids were received.

Bids were evaluated by the Sheriff’s Office and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

Tie bids were received for Items 1, 2, and 3. The award recommendations were determined in accordance with Commissioners Court Order No. 60616, Procedure for Awarding Tie Bids and Texas Government Code Section 2252.003(b) Non-Residential Bidders.

The term of the contract is twelve (12) months, effective June 20, 2025, with two (2) options for renewal periods of twelve (12) months each.

This contract is for specialized pistols, optics, and suppressors.

Therefore, it is the joint recommendation of the Sheriff’s Office and Purchasing that Bid No. F2025127, Annual Contract for Pistols, be awarded to the vendors listed above at the per unit price.
