COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of RFQ No. 2023-151, Annual Contract for Residential and Land Brokerage Services for Various Projects, for the second and final optional twelve (12) month period at the same contract terms.

BACKGROUND

On September 5, 2023, the Commissioners Court, through Court Order #141648, awarded RFQ No. 2023-151, Annual Contract for Residential and Land Brokerage Services for Various Projects, for Transportation Services/Right-of-Way Division, to the following vendors:

The awards were based upon evaluation criteria set forth in the RFQ specifications and contained options to renew for two (2) additional twelve (12) month periods.

On August 20, 2024, the Commissioners Court, through Court Order #143713, approved the first renewal option.

The purpose of this contract is to select the most qualified real estate brokerage firm to conduct negotiations at the seller's agent in the sale of County real estate, conduct market analysis as needed, and develop and implement marketing strategies to sell County real estate.

The vendor notified Purchasing in writing that they will extend the same contract terms through September 28, 2026. Transportation Services/Right-of-Way Division notified Purchasing in writing that they are pleased with the vendors and want to renew.



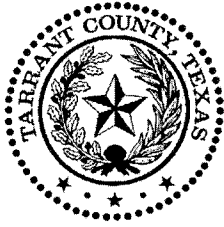
