It is requested that the Commissioners Court consider Amendment No. 1 for RFP No. 2022-181, Annual Contract for Pre-Court and Diversion Family Support Program, for Juvenile Services, with Lena Pope Home, Inc.

**BACKGROUND**

On September 27, 2022, the Commissioners Court, through Court Order #139276, awarded RFP No. 2022-181, Annual Contract for Pre-Court and Diversion Family Support Program, for Juvenile Services, to Lena Pope Home, Inc.

The award was based upon evaluation criteria set forth in the RFP specifications and contained options to renew for two (2) additional twelve (12) month periods.

On September 19, 2023, the Commissioners Court, through Court Order #141798, approved the first renewal option.

On October 1, 2024, the Commissioners Court, through Court Order #144020, approved the second and final renewal option.

The purpose of this contract is to provide comprehensive intervention services, including clinical assessment, counseling, skills-based training, coordinating of resources, and 24-hour crisis services to youth and their families referred to Juvenile Services and prior to adjudication by the juvenile court.

Amendment No. 1 revises Section 4.1 of the original contract by increasing the total not-to-exceed amount of the contract from \$192,176.00 to \$240,220.00, an increase of \$48,044.00.

Amendment No. 1 is attached for approval and signature. The District Attorney's Office reviewed this contract as to form.

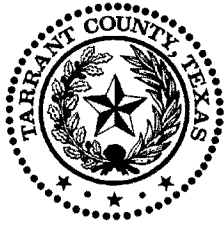
