After the contract was renewed, it was determined that it would be in the best interest of the County to obtain new bids to ensure best pricing for the Medical Examiner's Office. Therefore, Bid No. F2025008 was issued and awarded on February 4, 2025, which resulted in an annual savings of approximately \$11,000.00.

Tarrant County provided the vendors a thirty (30) day written notice of contract termination, as specified in the bid document, effective March 11, 2025.
