THE 26TH ANNUAL TARRANT COUNTY EMPLOYEE PICNIC AT
GLOBE LIFE FIELD**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider a Memorandum of Understanding between Tarrant County and Rangers Baseball LLC (Texas Rangers) for the 26th Annual Tarrant County Employee Picnic on Friday, August 22, 2025, at 7:05 PM and Saturday, August 23, 2025, at 6:05 PM.

BACKGROUND

Through this MOU, the Texas Rangers will reserve approximately 2,662 tickets for employees and their families and provide the following ticket options for each date, based on a \$20.00 County subsidy per ticket:

Tickets for August 22, 2025:

- All-You-Can-Eat Ticket: \$43.87 per ticket, before taxes and fees (valued at \$63.87)
- Seat-Only Ticket: \$1.16 per ticket, before taxes and fees (valued at \$21.65)

Tickets for August 23, 2025:

- All-You-Can-Eat Ticket: \$52.61 per ticket, before taxes and fees (valued at \$73.61)
- Seat-Only Ticket: \$5.98 per ticket, before taxes and fees (valued at \$25.98)

FISCAL IMPACT

Using the current County subsidy of \$20.00 per ticket, the County's cost, if all 2,662 tickets are sold, would be \$53,240.00. If the County elects a different cost-share arrangement, total expenditure could increase. There is no "minimum" ticket sales required, and no deposit is needed to reserve tickets. However, Tarrant County must issue a physical check based on actual tickets sold to the Texas Rangers by August 17, 2025, five days before the event. The Texas Rangers will present the County with an invoice during the week of August 11, 2025, for reimbursement at a rate of \$20.00 per ticket sold for the event. Tarrant County agrees to promptly issue a physical check of final payment to the Texas Rangers by August 17, 2025. Funds are available in account 10000-2025 General Fund/1820100000 Human Resources/ 579076 Service Awards.

**MEMORANDUM OF UNDERSTANDING BETWEEN
TARRANT COUNTY AND
RANGERS BASEBALL LLC**

This Memorandum of Understanding (the "Agreement") is entered into on _____ ("Effective Date") by and between Tarrant County ("County"), and Rangers Baseball LLC ("Texas Rangers"), with its principal location at 734 Stadium Drive, Arlington, Texas 76011.

TERMS AND CONDITIONS

PURPOSE: Texas Rangers has offered to create a Web Portal (defined below) for County's employees to purchase tickets for the Texas Rangers baseball games at Globe Life Field on August 22, 2025 at 7:05pm and August 23, 2025 at 6:05pm (the "Event(s)"). Tickets to the Event will include two options:

1. **All-You-Can-Eat Ticket:** This ticket provides an assigned seat in Sections 27-33 and includes an all-you-can-eat-meal.
2. **Seat Only Ticket:** This ticket provides an assigned seat in Section 302-306 and 318-324 ONLY. No Meal.

PURCHASE PRICE: County employees have two ticket options available for each Event, each with a different value (Calculations are based on the current \$20.00 per ticket subsidy):

1. Tickets to the Event on August 22, 2025:
 - a. **All-You-Can-Eat Ticket:** This Ticket value is \$63.87. The County Employee price will be \$43.87 per Ticket.
 - b. **Seat Only Ticket:** This Ticket Value is \$21.65. The County Employee price will be \$1.16 per Ticket.
2. Tickets to the Event on August 23, 2025
 - a. **All-You-Can-Eat Ticket:** This ticket is valued at \$73.61. The County Employee's price will be \$53.61 per ticket.
 - b. **Seat Only Ticket:** This ticket is valued at \$25.98. The County Employee's price is \$5.98 per ticket.

Please note that these prices do not include any applicable taxes or fees. (Approx. \$8.00 per ticket)

REIMBURSEMENT: The Texas Rangers will present the County with an invoice during the week of August 11th, 2025, for reimbursement at a rate of \$20.00 per ticket sold for the Event. Tarrant County agrees to promptly issue a physical check of final payment to the Texas Rangers five (5) days before the Event.

ENTIRE AGREEMENT: This Agreement represents the entire agreement between the parties. Any oral representations or modifications concerning this Agreement shall be of no force or effect unless contained in a subsequent writing signed by both parties. By their signatures below, the parties accept the terms of this Agreement in full.
