It is requested the Commissioners Court consider the submittal of FY 2025-2026 services grant contract renewal application to the Tarrant County HIV Administrative Agency to renew the Tarrant County Public Health (TCPH) Preventive Medicine Clinic (PMC) Grant Contract for Ryan White HIV/AIDS Program Part A, Part A Minority AIDS Initiative, and Texas HIV/State Services funding.

## **BACKGROUND**

For the past twenty (20) years the PMC has received annual funding in the form of Health Resources Services Administration (HRSA) and the Texas Department of State Health Services (DSHS) grant contracts through the Tarrant County HIV Administrative Agency (AA) to perform essential public health services that develop and enhance access to a comprehensive continuum of high quality, community-based medical care and support services for Persons Living With HIV/AIDS (PLWHA).

With approval, TCPH PMC will apply for the FY 2025-2026 grants. The expected term is March 1, 2025 through August 31, 2026, with two (2) additional one (1) year non-competing continuation renewal options. The total amount of funding requested is approximately \$1,000,000.00. There is no match amount for this contract.

The Budget and Risk Management Department has reviewed this grant application.
