It is requested that the Commissioners Court consider allowing the display of pinwheels and signs for Child Abuse Prevention Month on the lawn of the Northwest Subcourthouse.

BACKGROUND

The Tarrant County Child Protective Services (CPS) Board has requested to temporarily display eighteen (18) pinwheels and two (2) signs to raise awareness for Child Abuse Prevention month. The pinwheels will be silver and blue in color and the three signs will vary in size and will include the following messages:

- (1) 18"x24" – Child Abuse Awareness Month
- (1) 18"x24" – Pinwheel Information

The display will be placed on the lawn on Thursday, April 3, 2025 and removed on Wednesday, April 30, 2025.

CPS has completed and provided the required Tarrant County Facilities Management Property Use Application and the Release, Indemnification and Hold Harmless Agreement.


**RELEASE, INDEMNIFICATION
