COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider the submission of the Grant Year (GY) 2025 Urban Area Security Initiative Program Grant Application and Resolution to the Office of the Governor, Homeland Security Division for the Emergency Management Program Enhancement project.

BACKGROUND

The Office of the Governor’s Homeland Security Grant Program provides UASI funding to assist states and urban areas in enhancing the ability to prevent, protect against, respond to, and recover from terrorist attacks, major disasters, and other emergencies. This funding directly strengthens state and local preparedness for a range of potential threats.

Since 2004, Tarrant County has applied for and received funding through this grant program to support various projects related to emergency management.

If approved, GY 2025 UASI funds will continue to support the salary of one (1) full-time planning position. The planner will assist with resource identification, updating multiple plans, and other emergency management related activities. Additionally, the funds will cover costs related to planning such as registration fees and travel to conferences, trainings, and exercises.

The grant request is for \$151,178 to support the Emergency Management Program Enhancement project. The performance period for this grant is from January 1, 2026 through December 31, 2026.

The Budget and Risk Management Office has reviewed the budget for this application.

FISCAL IMPACT

The grant request is for \$151,178. This grant does not require match or operating subsidy. Indirect costs are allowed and have been added to the program budget.
