**SUBJECT: CONSIDERATION OF PROPOSED CHANGES TO CERTAIN VOTING  
PRECINCT BOUNDARIES**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court consider proposed changes to certain voting precinct boundaries.

**BACKGROUND**

Texas Election Code Section 42.031 requires Commissioners Courts to review county election precinct boundaries in March or April of each odd-numbered year to determine whether any changes are needed for compliance with Sections 42.005, 42.006, and 42.007. Any necessary changes must be adopted by May 1 of that year.

Additionally, Section 42.036 requires counties with a population of one million or more to notify, in writing, the county chair of each political party that held a primary election, as well as the appointed precinct chairs and presiding judges of the affected election precincts.

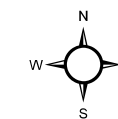
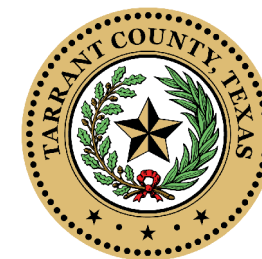
On April 2, 2025, the Commissioners Court, through Court Order #144939, authorized the Elections Administrator to notify, in writing, the county chair of each political party that held a primary election, as well as the appointed precinct chairs and presiding judges of the affected election precincts, of the proposed changes to certain voting precinct boundaries.

If the plan is approved, the Elections Administrator will forward the proposed changes to the Secretary of State on behalf of the Commissioners Court and inform the party and precinct chairs, as well as the presiding judges, of the impacted precincts.

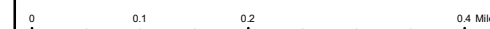
# PRECINCT 3209 ACTIVE VOTERS 4,465

- Sub-Precincts

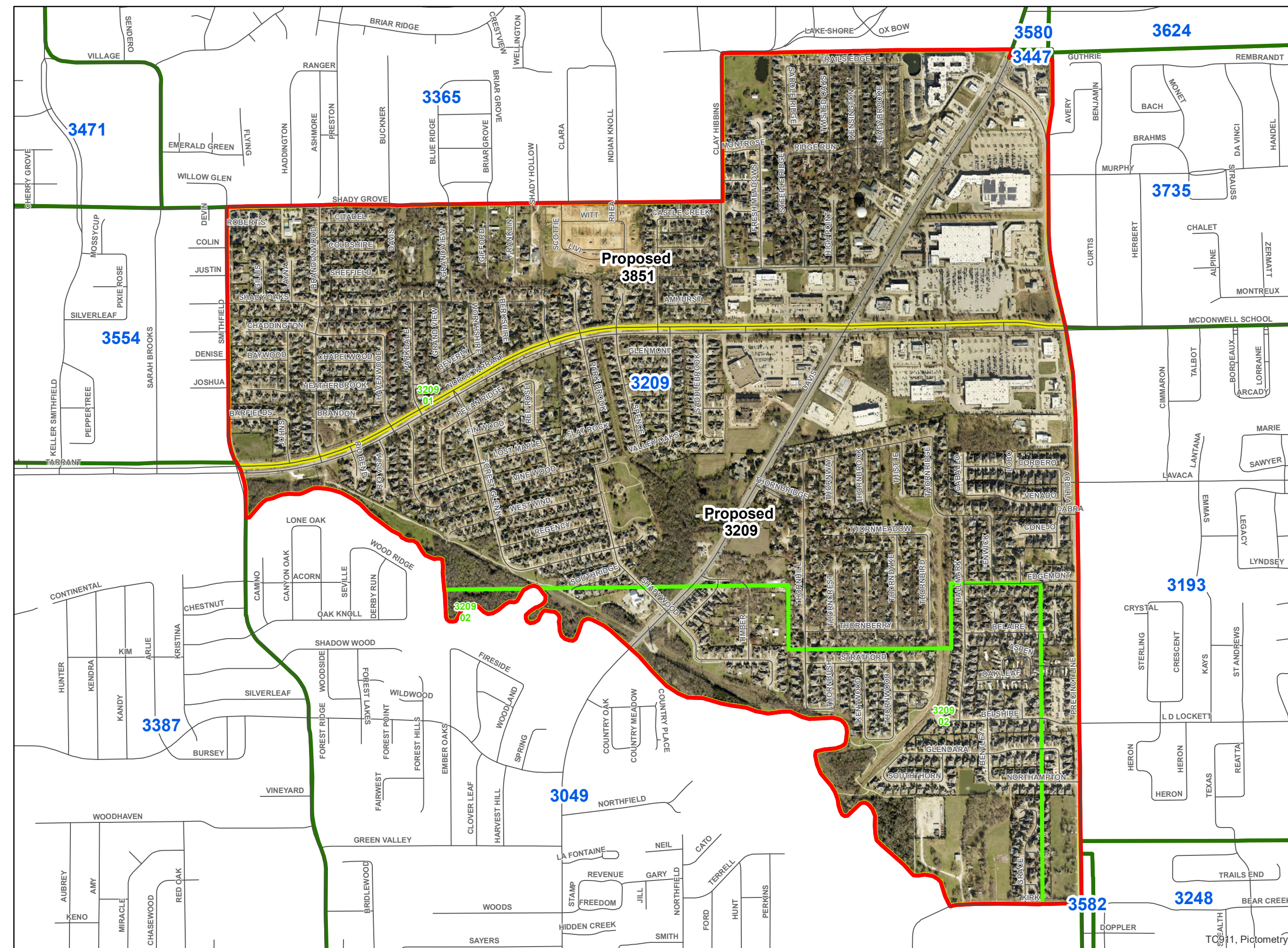

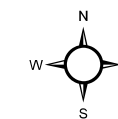

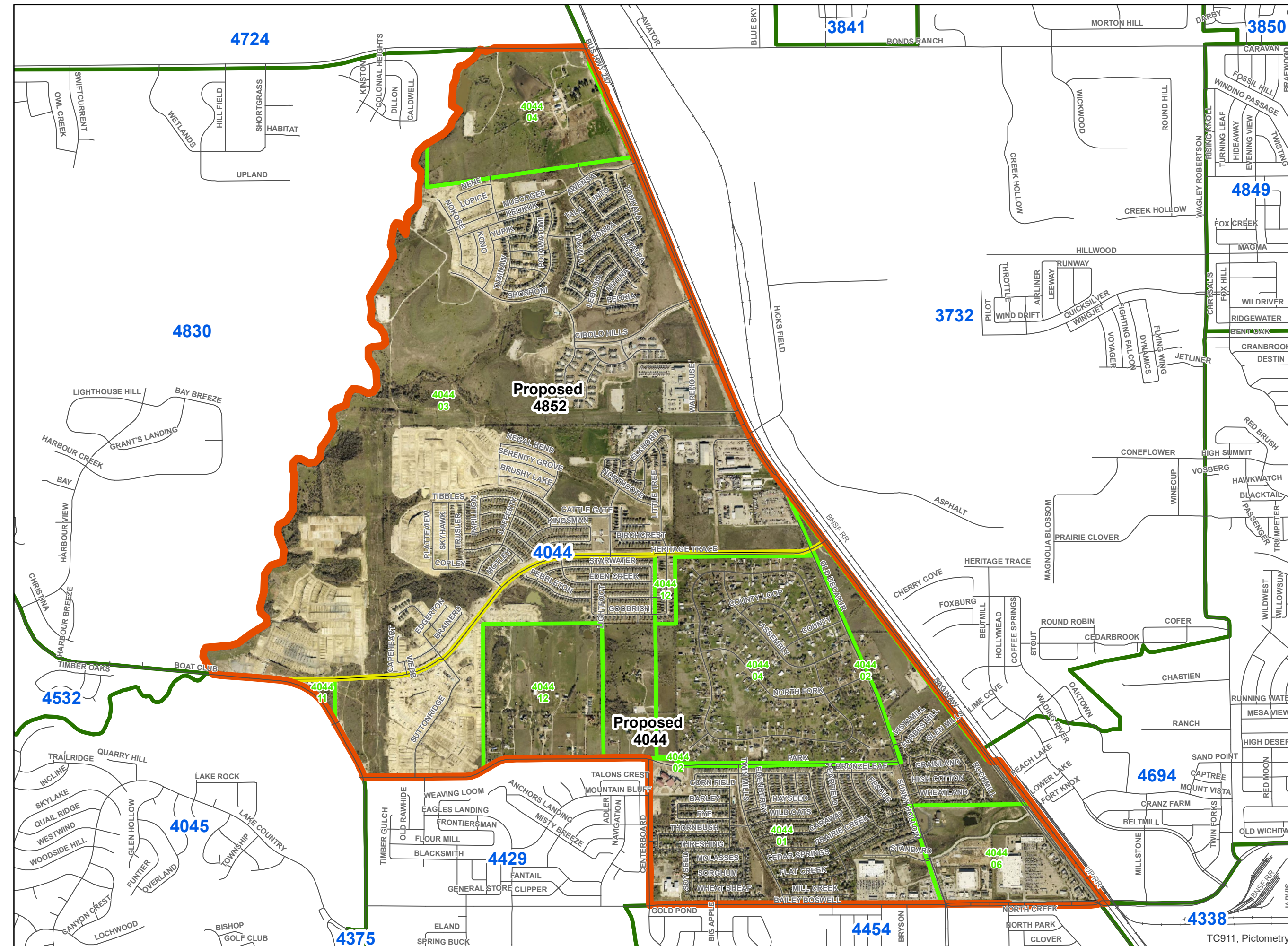
