**SUBJECT: CONSIDERATION TO RECEIVE AND FILE THE 2024 RACIAL
PROFILING DATA FROM TARRANT COUNTY SHERIFF'S OFFICE**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider receiving and filing the 2024 Racial Profiling Data from the Tarrant County Sheriff's Office

BACKGROUND

The 77th Legislature for the State of Texas enacted Senate Bill 1074 which mandated that law enforcement agencies implement specific policies and procedures to prevent racial profiling by certain peace officers. The Sheriff's Office has implemented a process to compile and analyze data from traffic stops as stipulated in Senate Bill 1074. Through Court Order #86841 on December 18, 2001, the Commissioners Court approved the Tarrant County Profiling Policy.

In accordance with Senate Bill 1074, the Tarrant County Sheriff's Office has attached the following documents: Racial Profiling Data with tables on the numbers of stops and contacts in 2024; a Comparative Analysis of the number of licensed individuals in Tarrant County based upon most recent drivers' license data from the Texas Department of Public Safety and most recent available population estimates from the U.S. Census Bureau; a copy of the Tarrant County Racial Profiling Policy approved by the Commissioners Court on December 18, 2001; and a copy of the Web page on the Sheriff's Office web site that outlines the process to file complaints about Racial Profiling.

The Tarrant County Sheriff's Office received no reports or complaints of Deputies engaging in racial profiling in 2024. Internally, the Sheriff's Office will continue to review the racial profiling data entered by individual Deputies.

There is no fiscal impact to Tarrant County for this item.

In compliance with Senate Bill 1074 of the 77th Legislature, the Tarrant County Sheriff's Office is providing the data collected regarding traffic stops, contacts, and searches during the calendar year 2024. Attached are the following documents:

- Racial profiling data with charts on the number of contacts by race, contacts by violation, searches by race and final outcomes by race;
- A copy of the Tarrant County Racial Profiling Policy approved by the Commissioners Court; and
- A link to the Tarrant County Sheriff's website that outlines the process to file complaints regarding racial profiling

In 2024, the Tarrant County Sheriff's Office recorded a total of 14,680 traffic stops within the racial profiling reporting system. This number reflects an increase of 13% in traffic stops over the 2023 total of 12,891. Hazardous violations comprised 35% of the total stops and the non-hazardous percentage was the remaining 65%.

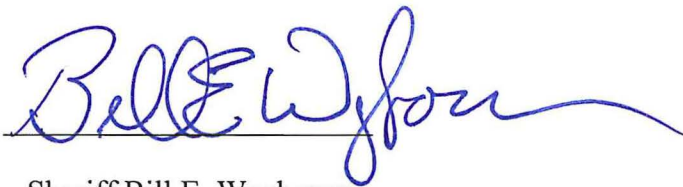
Contacts by race as a percentage of total traffic stops are: stops of white drivers totaled 48% of all stops in 2024, a decrease of 4% from 2023. Hispanic drivers accounted for 24% a slight increase of 1% from 2023. African American drivers reflected a total of 24% of total stops increase of 3% of total stops from 2023. Stops of Asian drivers increased slightly from 1.8% to 1.9% of all violator stops. Stops of Middle Eastern and Native American drivers accounted for 1.4% of the total stops. The yearly variance in the contact data, i.e., contacts by race as a percentage of total stops, are most likely reflective of the changing demographics of the driving population within the county.

Deputies were able to discern the driver characteristics prior to the stop at the ratio of 3% of stops (469 of 14,680). Deputies recognized the violator before the stop on 57 occasions, less than 1% of the total stops. Recognizing the violator prior to the stop is indicative of the driver being known to the deputy from previous contacts.

Enforcement action in 2024 occurred in 6% of contacts (885), which is a decrease from the 2023 enforcement of 11%. White drivers received 48% of enforcement action in 2024, a increase of 5% from 2023. The African American driver enforcement action resulted in 24% of the total, a percentage decrease of 1% from 2023. Hispanic drivers receiving enforcement action made up 24% of the total, resulting in an decrease of 4% over 2023. Asian drivers consisted of 2% of overall enforcement. Middle Eastern and Native American enforcement ratios combined were 1%.

Deputies conducted 998 vehicle searches in 2024 (7% of all stops), which reflects an increase of .5% compared to 2023. Deputies conduct vehicle searches when they develop probable cause to believe contraband is present, upon plain view of contraband, when the search is incident to an arrest, or after arrest and during the inventory of the vehicle prior to towing. Those searches accounted for 716 of the total searches (43%). The remaining 282 were incidents where the driver provided consent to the deputy to conduct a search. Deputies located contraband in 335 searches, with the most common items of contraband seized being drugs (259 seizures), alcohol (55 seizures) and weapons (9 seizures). In 2024 deputies made 325 arrests out of 14,680 total stops (2.2%).

The Tarrant County Sheriff's Office did not receive any complaints of racial profiling in 2024. The Sheriff's Office monitors the activities of deputies by monitoring and observing the actions of deputies regarding racial profiling, including reviews of traffic stop videos, and reviews of reporting standards and compliance. The department's policy prohibiting racial profiling and the procedures for filing a complaint of racial profiling can be found on the Tarrant County Sheriff's Office public access web site, <http://access.tarrantcounty.com/en/sheriff.html> under the Administration tab, or the inquire tab.

TARRANT COUNTY RACIAL PROFILING POLICY

WHEREAS, Senate Bill 1074 was recently passed by the Legislature of the State of Texas prohibiting a peace officer from engaging in racial profiling;

WHEREAS, Senate Bill 1074 requires that not later than January 1st, 2002, a law enforcement agency covered by the law must adopt and implement a policy and begin collecting information under the policy;

WHEREAS, the Tarrant County Sheriff and the Constables of Tarrant County are now adopting, before the Tarrant County Commissioners Court, a policy prohibiting racial profiling by their agencies;

NOW, THEREFORE, the Tarrant County Sheriff and the Constables of Tarrant County (hereinafter collectively referred to as "agencies") adopt the following policy:

Section 1.

Racial profiling is defined as any law enforcement-initiated action based on an individual's race, ethnicity, or national origin rather than on the individual's behavior or on information identifying the individual as having engaged in criminal activity.

Section 2.

All peace officers employed by the agencies are strictly prohibited from engaging in racial profiling. All law enforcement-initiated actions, which include all investigative detentions, traffic stops, arrests, searches and seizures of persons and/or property shall be based on a standard of reasonable suspicion or probable cause as required by law. All peace officers of the agencies must be able to articulate specific facts, circumstances and conclusions, which support probable cause or reasonable suspicion for the investigative detention, traffic stop or arrest.

Section 3.

All peace officers employed by the agencies shall not consider an individual's race, ethnicity, or national origin in establishing either reasonable suspicion, probable cause or as a basis for requesting consent to search the individual or his or her property.

Section 4.

All peace officers employed by the Tarrant County Sheriff's Office must "check out" via radio on every vehicle or subject stop. At the conclusion of each stop, the peace officer will complete either a computerized or written form, capturing all data elements required to be obtained by law. This information will then be uploaded from the MDC to a computer database (if a computerized form) or manually inputted into a computer database (if a written form).

Section 5.

No peace officer employed by the agencies will conduct a search of a person or vehicle after peace officer-initiated contact without completing a written report detailing the search and the facts supporting it. In the event no offense or arrest report is appropriate, a Miscellaneous Incident report will be completed.

Section 6.

If an individual believes that a peace officer employed by any of the agencies has engaged in racial profiling with respect to the individual then the following complaint process shall govern:

A. Sheriff: If an individual believes that a peace officer employed by the Sheriff's Office has engaged in racial profiling with respect to the individual then the individual must file a written complaint before the 180th day after the alleged violation with the Tarrant County Sheriff's Department Internal Affairs Division located at 200 Taylor Street, Fort Worth, Texas 76102.

B. Constable: Refer to Constable Contact Page

Section 7.

The agencies will provide public education relating to the agencies complaint process via the Tarrant County web site located at www.tarrantcounty.com.

Section 8.

Appropriate corrective action will be taken against a peace officer employed by the agencies who, after an investigation, is shown to have engaged in racial profiling in violation of this policy.

Section 9.

The agencies will collect information as required by law relating to traffic stops in which a citation is issued and to arrests resulting from those traffic stops, including information relating to:

A. The race or ethnicity of the individual detained; and

B. Whether a search was conducted and, if so, whether the person detained consented to the search.

Section 10.

Each agency will submit to the Tarrant County Commissioners Court an annual report of the information collected pursuant to Section 9 above. Each agency shall first submit information to the Tarrant County Commissioners Court on March 1, each year. The first submission of information shall consist of information compiled by each agency during the period beginning January 1, each year, and ending December 31, each year. The report may not include identifying information about a peace officer who makes a traffic stop or about an individual who is stopped or arrested by a peace officer.

THIS POLICY is effective this the 18th day of December, 2001

You may contact the Internal Affairs Division referencing the apparent misconduct by a Tarrant County Sheriff's Department employee in person, or by calling 817-884-1108. Office hours are Monday - Friday, 8 a.m. - 5 p.m., (excluding County holidays). After office hours, a message and return phone number may be left via voice mail and the call will be returned the following business day.

The Internal Affairs Division will investigate any calls that appear to be Level III. The result of these investigations may result in severe disciplinary action, up to loss of employment, or possible criminal investigation. Because of the severe consequences of sustained Third Level Complaints you must come to the Sheriff's Office to complete and sign a formal complaint form. If you are unable to come to the Sheriff's Office, accommodations will be made.

The complaint process generally takes the Department 60 calendar days to complete the investigation and for the Board of Disciplinary Review to determine what discipline shall be recommended and/or imposed.



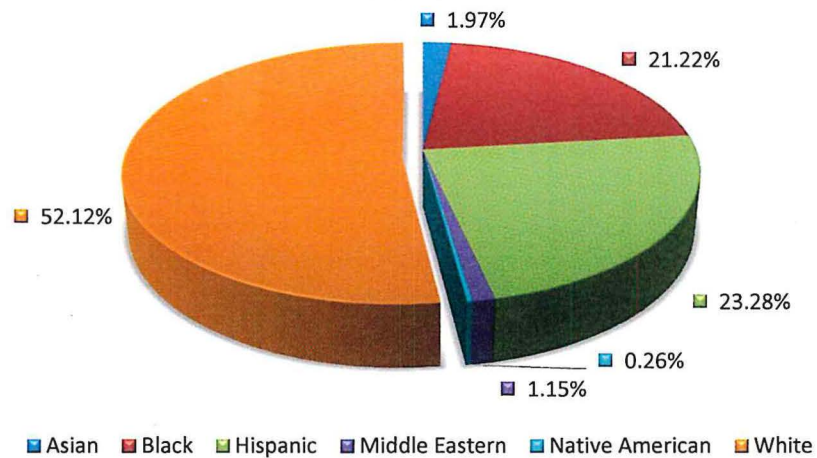

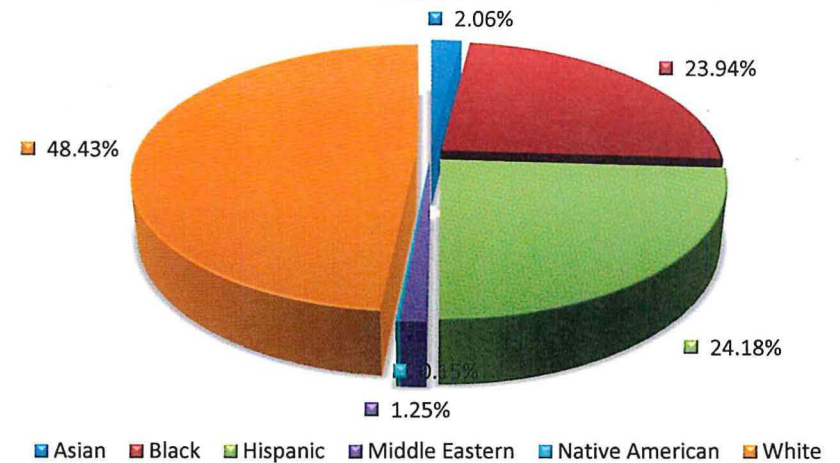
Contact By Race 2023 vs 2024

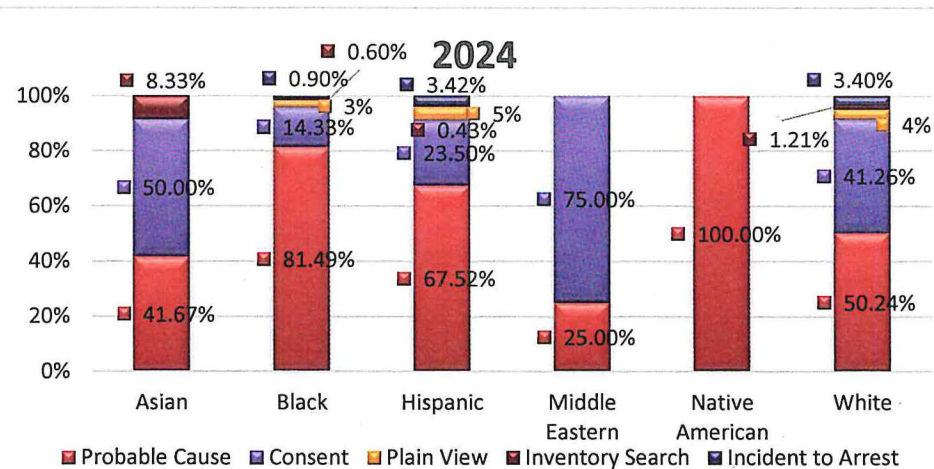
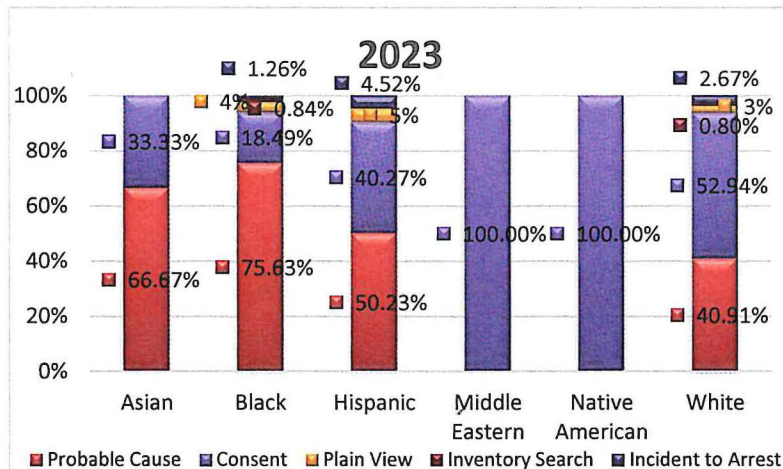

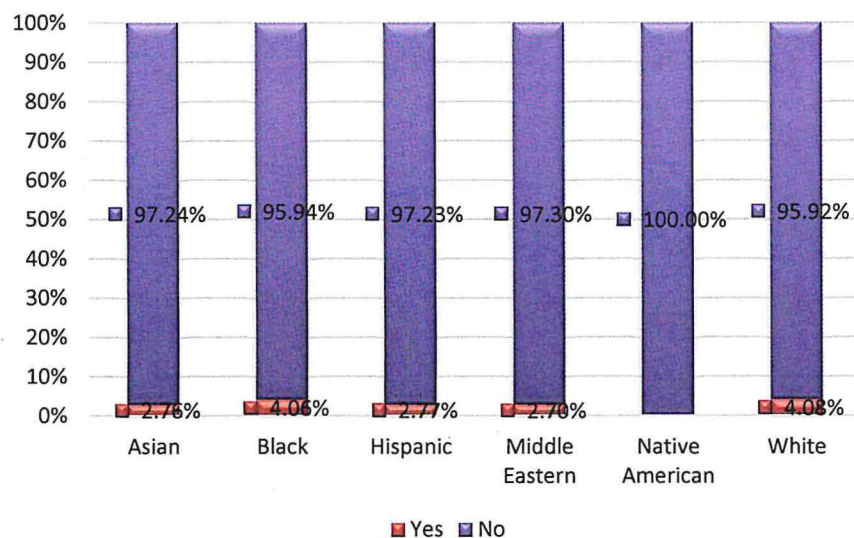


Observe Driver Characteristics 2023 vs 2024

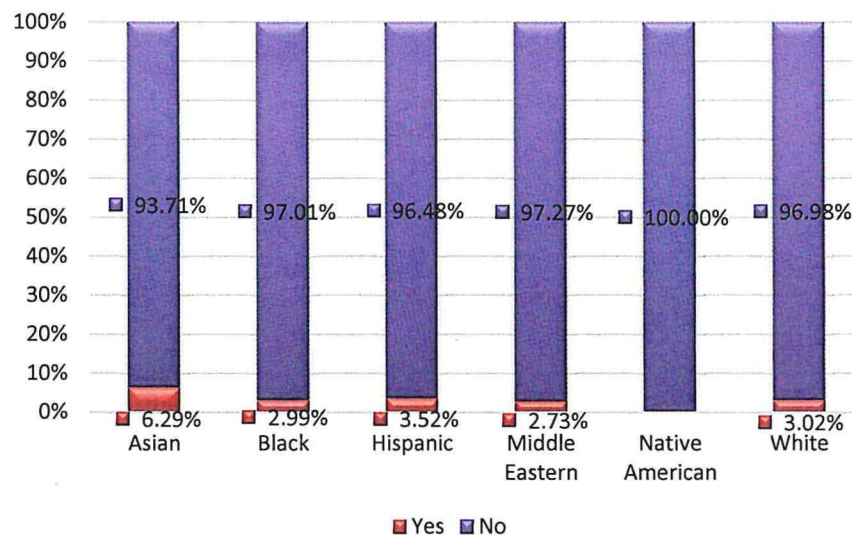

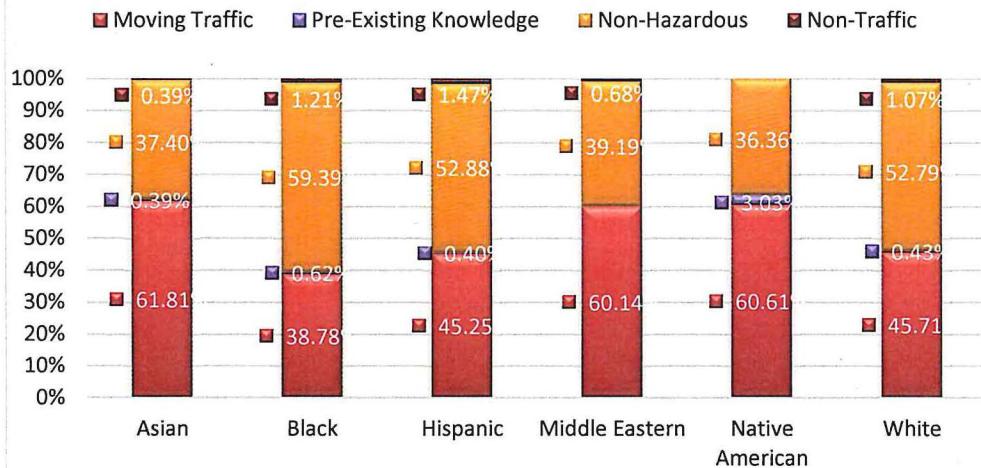


Reason for Stop 2023 vs 2024

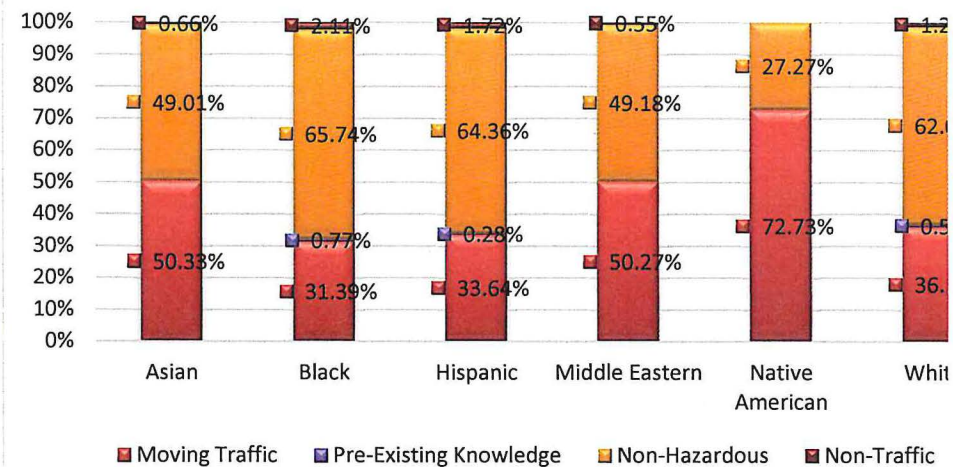

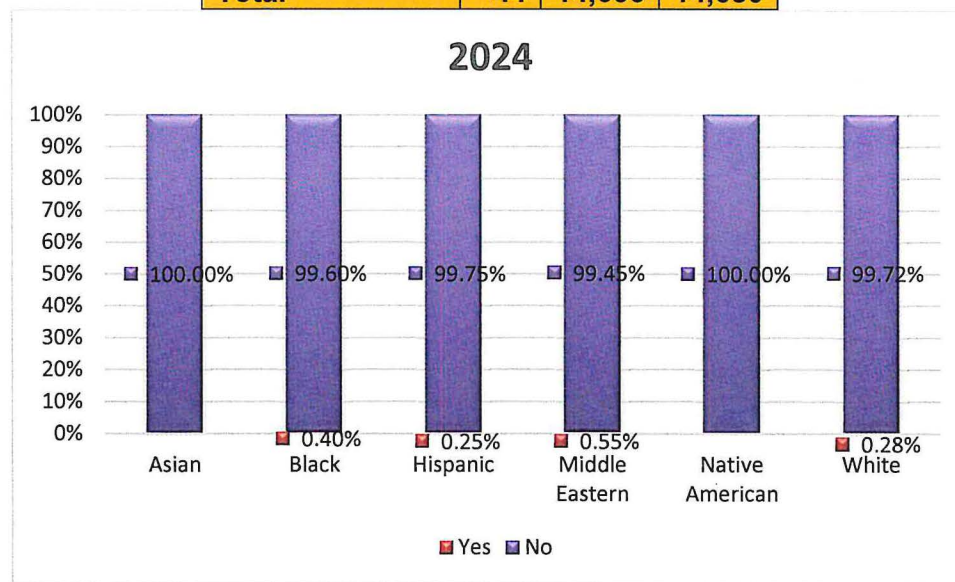

The above listed license data was obtained by the Tarrant County Sheriff's Office in January 2024 and January 2025. Starting in 2020, DPS stopped tracking "Hispanic" as a separate category and put this information in the "Other" category. "Hispanic" was provided by DPS in January 2025 as a whole, but the same "Hispanic" data was still also counted in the "White" and "Other Category". As a result, the "Hispanic" data could not be used. The Tarrant County Sheriff's Office started tracking data on "Indian" or "Native American" and "Middle Eastern" in 2010. Since the Tarrant County Sheriff's Office does not keep data on "Other", the 7.4% for "Other" was placed in the "White" category which makes it 72.4% "White" for 2024.

The Texas Department of Public Safety does not make a distinction between "White" and "Middle Eastern". In addition, the Texas Department of Public Safety started tracking "Hispanic" in 2020 as an Ethnic Group and not a Race. "Hispanic" data was provided to TCSO for 2024, but it appears most "Hispanic" data was placed in the "Other" category or "White" category when compared to previous years.

The above License data was obtained by the Tarrant County Sheriff's Office in January 2023 and January 2024. The license data is all license data tracked by the Texas Department of Public Safety.

Since TCSO does not keep data on "Other", the "Other" was placed in the "White" category which makes it 73.0% total "White" in 2023 and 72.4% total "White" in 2024. TCSO was informed that DPS stopped tracking "Hispanic" as a race and included this information in "White" or "Other" categories. The 2023 "Hispanic" data was provided by DPS to TCSO still also appears to be tracked in "White" or "Other" categories and was not used.

*License information obtained from the Texas Department of Public Safety (DPS) in January 2021. Per DPS in January 2022, they were NOT going to release any new drivers' license data from 2021 at that time.

**The Texas Department of Public Safety started in 2011 tracking "Hispanic" in a separate category, only a small number of "Hispanics" have renewed or received a license since the change was made. As a result, only starting in 2016 was there significant number of "Hispanics" listed in the data from the Texas Department of Public Safety to create a separate category for this report. However, DPS informed TCSO in January 2021 that they no longer track "Hispanic" as a separate race category, but as an "Ethnic" group. As a result, "Hispanic" was now placed in the "White" or "Other" category.

License information from 2010 includes "Hispanic" and "Pacific islander" in the "White" category. "Pacific Islander" is now included in the "Asian" category.

Prior to 2010, the Texas Department of Public Safety compiled and provided the above race data by zip code only and not for Tarrant County. only in these years. This caused the number of licensed drivers to be elevated in these years because it included a number of licensed drivers from zip codes that crossed Tarrant County lines into adjacent counties. In the years 2010, 2011 and 2012 to present, the Texas Department of Public Safety provided race data for the entire Tarrant County.

The Texas Department of Public Safety recently started tracking the "Hispanic" category in 2011, but only a small number of Hispanics have either received a drivers' license or had a drivers' licensed renewed. TCSO was informed in January 2021 that "Hispanic" was no longer tracked as a stand alone race category by the Texas Department of Public Safety, but it was now tracked in the "Other" or "White" category.
