**SUBJECT: BID NO. F2024175 - PURCHASE OF FBI CERTIFIED SLAP SCANNERS -
CRIMINAL COURTS - DATAWORKS PLUS, LLC**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award Bid No. F2024175, Purchase of FBI Certified Slap Scanners, for Criminal Courts, to Dataworks Plus, LLC for \$22,400.00.

BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Seven hundred forty-three (743) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested parties. No vendors attended the pre-bid conference held on August 5, 2024. Three (3) bids and seven (7) no-bids were received.

The low bid received from Dataworks Plus LLC meets all specifications and is acceptable to Criminal Courts.

The term of the contract is six (6) months, effective October 1, 2024.

The purpose of this contract is to equip Criminal Court bailiffs at the Tim Curry Criminal Justice Center with slap-scan devices on each courtroom floor. These devices will facilitate the capture and transmission of individuals' fingerprints to the FBI's Next Generation Identification System, ensuring positive identification of individuals involved in crimes within Tarrant County. By capturing fingerprints at court hearings, a tracking number for the criminal offense will be generated, which must be reported to the Office of Criminal Court by the disposing court.

Therefore, it is the joint recommendation of Criminal Courts, and Purchasing that Bid No. F2024175, Purchase of FBI Certified Slap Scanners, be awarded to Dataworks Plus, LLC, for \$22,400.00.

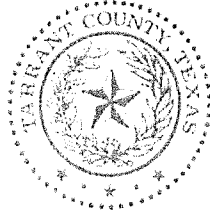

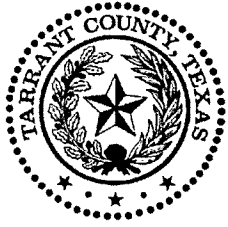
