SUBJECT: CONSIDERATION OF A GRANT AGREEMENT BETWEEN TARRANT COUNTY AND STEM IT UP SPORTS TO PROVIDE SUPPORT SERVICES TO TARRANT COUNTY RESIDENTS

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve a grant agreement between Tarrant County and STEM It Up Sports to provide support services to the residents of Tarrant County.

BACKGROUND

Commissioner, Precinct 2's Community Organization Program was created to support proactive and hard-working organizations in Tarrant County. The program targets organizations whose goals are to better the community and help citizens in need. Some examples of related initiatives may include Youth Programs, Public Health (Physical and Mental), Housing, Education and Criminal Justice Reform.

STEM It Up Sports has been selected to receive Precinct 2 Community Outreach Program funds to deliver STEM enrichment programming through camps such as Wings of Innovation and Camp STEM It Up. These programs introduce youth to science, technology, engineering, and math through hands-on activities including robotics, drones, e-sports, animation, and game design. The camps foster creativity, leadership, and critical thinking while increasing awareness of STEM career pathways.

If awarded, funding in the amount of \$3,500.00 will support costs associated with instructional materials, staffing, supplies, and program implementation for STEM-based enrichment activities in Tarrant County.

This grant agreement has been approved as to form by the Criminal District Attorney's Office.

FISCAL IMPACT

Funding in the amount of \$3,500.00 is available in account 10000-2025 General Fund/6210100000 Precinct 2 General/579061 County Projects.

AGREEMENT

WHEREAS, **STEM IT UP SPORTS** is a nonprofit youth development organization that engages students in STEM-based programs focused on leadership, confidence, and critical thinking; and

WHEREAS, the Tarrant County Commissioners Court hereby finds that the program provided by **STEM IT UP SPORTS** benefits the residents of Tarrant County, Texas, and hereby declares that this **Agreement** is one of a professional service;

NOW, THEREFORE, this **Agreement** is made and entered into this 17th day of June 2025, by and between **STEM IT UP SPORTS** acting by and through its duly authorized agent, and **TARRANT COUNTY, TEXAS ("COUNTY")**, acting by and through its County Judge.

STEM IT UP SPORTS and the **COUNTY** agree as follows:

1. **STEM IT UP SPORTS** provides STEM-based programming that includes hands-on camps such as Wings of Innovation STEM Camp and Camp STEM It Up. These camps offer students opportunities to explore robotics, drones, esports, animation, and game design through creative and interactive experiences. Programs are designed to spark curiosity, build real-world skills, and inspire interest in STEM careers.

2. **COUNTY**, for and in consideration of the services provided, agrees to pay to **STEM IT UP SPORTS** a lump sum payment of **\$3,500.00** for services rendered to the residents of Tarrant County, Texas for the fiscal year beginning October 1, 2024, and ending September 30, 2025.

3. **TO THE EXTENT ALLOWED BY TEXAS LAW, STEM IT UP SPORTS HEREBY AGREES TO INDEMNIFY AND HOLD HARMLESS COUNTY, ITS OFFICERS, AGENTS, OFFICIALS, AND EMPLOYEES FROM ANY LOSS, DAMAGE, INJURY OR CLAIM ARISING FROM THE NEGLIGENT OPERATION OF ITS PROGRAM. SAID INDEMNIFICATION WILL INCLUDE, BUT NOT BE LIMITED TO, ALL AMOUNTS OF ALL CLAIMS, ATTORNEYS' FEES, AND COSTS OF COURT.**

4. Nothing contained in this **Agreement** shall be deemed or construed by the parties hereto, nor by any third party, as creating the relationship of principal and agent, partnership, joint enterprise, common enterprise, joint venture, joint owners, or joint tenants between the parties. The parties hereby declare and acknowledge that the relationship existing is one of independent contractor. This **Agreement** does not and shall not be construed to entitle either party or any of their respective employees or officials, if applicable, to any benefit, privilege or other amenities of employment from the other party.

5. This **Agreement** shall not be interpreted to inure to the benefit of a third party not a party to this **Agreement**. This **Agreement** may not be interpreted to waive any statutory or common law defense, immunity, including governmental and sovereign immunity, or any limitation of liability, responsibility, or damage of any party to this **Agreement**, party's agent, or party's employee, otherwise provided by law.

6. The parties to this **Agreement** will not sell, assign, transfer or convey any benefits or obligations of this **Agreement** in whole or part without the prior written consent of both parties.
7. If any one or more of the provisions contained in this **Agreement**, for any reason, be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability will not affect any other provision of this **Agreement**.
8. This **Agreement** constitutes the entire agreement between the parties, and any and all prior negotiations are merged into this **Agreement**. Any amendment, change, or addition to this **Agreement** shall be made only in writing and signed by both parties.
9. This **Agreement** will be governed by and construed according to the laws of the State of Texas. Venue for any action or claim arising from this **Agreement** will be in Tarrant County, Texas, as to state court actions, and the United States District Court for the Northern District of Texas, as to federal court actions.
10. In providing the services required by this **Agreement**, **STEM IT UP SPORTS** must observe and comply with all applicable federal, state, and local statutes, ordinances, rules, and regulations, including, without limitation, workers' compensation laws, minimum and maximum salary and wage statutes and regulations, and non-discrimination laws and regulations. **STEM IT UP SPORTS** shall be responsible for ensuring its compliance with any laws and regulations applicable to its business, including maintaining any necessary licenses and permits.
11. **STEM IT UP SPORTS** agrees to provide **COUNTY** all records relating to the programs performed by **STEM IT UP SPORTS** upon written request of **COUNTY** and to provide a final report detailing the manner in which such funds are expended and the program details of its services.
12. **STEM IT UP SPORTS** shall use the aforementioned lump sum payment of **\$3,500.00** by **COUNTY** to support STEM-based programming, including the Wings of Innovation STEM Camp and Camp STEM It Up.
13. **STEM IT UP SPORTS** must submit to **COUNTY** a final report as to the program outcomes achieved within sixty (60) days of the end of the requested funding year (by November 30, 2025) by providing the following:
 - (a) a program update on all outcomes accomplished and client populations served; and,
 - (b) an accounting of all expenditures of **COUNTY** funds (salary, rent, training, etc.).
*Any funds not used for the specified purposes or not used within the time limits specified in this contract are subject to be returned to **COUNTY**.*

Until receipt of this final report by **COUNTY**, all subsequent funding will be held in abeyance.

14. **STEM IT UP SPORTS** verifies that it does not boycott Israel and will not boycott Israel during the term of this contract. The term "boycott Israel" is as defined by Texas Government Code Section 808.001, effective September 1, 2017.

15. **STEM IT UP SPORTS** acknowledges and agrees that it has fully, accurately, and completely disclosed all interested parties in the attached Form 1295 and has acknowledged the completeness of this disclosure by filing the Form 1295, attached as Exhibit A, with the Texas Ethics Commission as required by law.
