**SUBJECT: RFP NO. F2025068 - ANNUAL CONTRACT FOR THIRD-PARTY RISK AND ATTACK SURFACE MANAGEMENT PLATFORM AND MAINTENANCE - INFORMATION TECHNOLOGY**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court reject all proposals for RFP No. F2025068, Annual Contract for Third-Party Risk and Attack Surface Management Platform and Maintenance, and grant permission to rebid with revised specifications.

**BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Eight hundred sixty-one (861) vendors were contacted and requested to participate in this proposal process. All documents pertaining to this proposal were posted on the Tarrant County website and were downloaded by interested parties. A pre-proposal conference held on January 6, 2025, was attended by six (6) vendors as well as representatives from Information Technology and Purchasing. Six (6) proposals and nine (9) no-bids were received.

After evaluation by Purchasing representatives, it was determined that there were flaws in the quality of the specifications and that assumptions would have to be made to present an award recommendation.

Therefore, it is the joint recommendation of Information Technology and Purchasing that the Commissioners Court reject all proposals received for RFP No. F2025068, Annual Contract for Third-Party Risk and Attack Surface Management Platform and Maintenance, and grant permission to rebid with revised specifications.
