SUBJECT: CONSIDERATION OF AMENDMENT NO. 4 TO THE FISCAL YEAR 2025-2026 TEXAS DEPARTMENT OF STATE HEALTH SERVICES HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS CONTRACT

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider Amendment No. 4 to the FY 2025-2026 Texas Department of State Health Services (DSHS) Housing Opportunities for Persons with AIDS (HOPWA) Contract.

BACKGROUND

Tarrant County annually receives funding from DSHS HOPWA in the form of grants. The DSHS HOPWA program helps low-income persons living with HIV and their households to establish or maintain affordable and stable housing. Stable housing reduces the risk of homelessness and improves health outcomes.

On June 06, 2023, the Commissioners Court, through Court Order #140986, approved the FY23-24 Texas DSHS HOPWA Grant Contract in the amount of \$312,416.00.

On April 16, 2024, the Commissioners Court, through Court Order #140986, approved Amendment No. 1 to the FY 2024-2025 Texas DSHS HOPWA Contract in the amount of \$312,416.00, for a total of \$624,832.00.

On September 04, 2024, the Commissioners Court, through Court Order #143794, approved Amendment No. 2 to the FY 2024-2025 Texas DSHS HOPWA Contract in the amount of \$667.00, for a total of \$625,449.00.

On May 06, 2025, the Commissioners Court through Court Order #145150, approved Amendment No. 3 to the FY 2025-2026 Texas DSHS HOPWA Contract in the amount of \$313,083.00, for a total of \$938,582.00.

With approval of Amendment No. 4 to the FY 2025-2026 Texas DSHS HOPWA Contract, funding will increase by \$23,870.00 for a total of \$962,452.00.

The project period is September 1, 2023, through August 31, 2026. The term of this contract is September 1, 2025, through August 31, 2026.

The Criminal District Attorney's Office has reviewed these documents as to form.

AMENDMENT No. 4**

The **DEPARTMENT OF STATE HEALTH SERVICES** (“DSHS” or “System Agency”) and **TARRANT COUNTY** (“Grantee”), collectively referred to as the “Parties” to that certain grant contract for HIV/Housing Opportunities for Persons with AIDS (“HOPWA”) services, effective September 1, 2023, and denominated DSHS Contract No. HHS001317100005 (the “Contract”), as amended, now desire to further amend the Contract.

WHEREAS, DSHS desires to add funds to the Contract for State Fiscal Year 2026 (September 1, 2025, through August 31, 2026), and revise the Budget accordingly.

NOW, THEREFORE, the Parties amend and modify the Contract as follows:

1. **SECTION V, BUDGET AND INDIRECT COST RATE**, of the Contract is amended to add \$23,870.00 for authorized services provided from September 1, 2025, through August 31, 2026, for a new total not-to-exceed Contract amount of \$962,452.00. All payments under the Contract shall be made in accordance with **ATTACHMENT B-4, REVISED BUDGET**.
2. **ATTACHMENT B-3, REVISED BUDGET**, of the Contract is deleted in its entirety and replaced with **ATTACHMENT B-4, REVISED BUDGET**, which is attached to this Amendment No. 4 and incorporated into and made part of the Contract for all purposes.
3. This Amendment No. 4 shall be effective on the signature date of the latter of the Parties to sign this Amendment.
4. Except as amended and modified by this Amendment, all terms and conditions of the Contract, as previously amended, shall remain in full force and effect.
5. Any further revisions to the Contract shall be by written agreement of the Parties.
6. Each Party represents and warrants that the person executing this Amendment No. 4 on its behalf has full power and authority to enter into this Amendment.

C. The Grantee shall submit a Financial Status Report (FSR) for the two reporting intervals outlined below by the respective due date. If the due date falls on a weekend or holiday, the due date is the following business day.

Grantee must email the FSR to: FSRGrants@dshs.texas.gov and send a copy to the DSHS Contract Manager. Grantee must submit invoices monthly to prevent delays in subsequent months. Even if the Grantee does not incur expenses for a month, the Grantee must still submit timely “zero dollar” invoices. Grantee must email invoices and all supporting documentation to invoices@dshs.texas.gov and cmsinvoices@dshs.texas.gov simultaneously. The Grantee shall submit an annual close-out invoice and final FSR no later than forty-five (45) calendar days after the end of the State Fiscal Year. DSHS may deny payment for invoices received more than forty-five (45) calendar days after the end of the State Fiscal Year.


