It is requested that the Commissioners Court award Bid No. F2025171, Annual Contract for Fitness Classes and Personal Trainer Sessions, Countywide, to the following vendors at the per hourly rates:

Alternate	Righteous Livity Works

BACKGROUND

Notice of the County's intent to bid was advertised in a local newspaper, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Two hundred thirty-three (233) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on June 18, 2025 was attended by one (1) vendor as well as representatives from Human Resources and Purchasing. Four (4) bids and one (1) no-bid were received.

Bids were evaluated by Human Resources and Purchasing representatives. Award recommendations are to the low bid meeting specifications.

The term of the contract is twelve (12) months, effective October 1, 2025, with two (2) options for renewal periods of twelve (12) months each.

The purpose of this contract is for fitness classes and personal trainer sessions for Tarrant County employees.

Therefore, it is the joint recommendation of Human Resources and Purchasing that Bid No. F2025171, Annual Contract for Fitness Classes and Personal Trainer Sessions, be awarded to the vendors listed above at the per hourly rates.

FISCAL IMPACT

Expenses for the last twelve (12) months was \$55,640.00. Funding has been requested in the FY 2026 budget request.

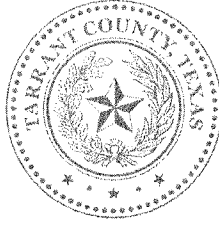
