Early Voting Ballot Board Alternate Judge: Katherine Cano (D)

Central Counting Station Presiding Judge: Amie Super (R)
Central Counting Station Alternate Judge: Katherine Cano (D)

BACKGROUND

The Presiding and Alternate Judges of the early voting ballot board and Central Counting Station are appointed by Commissioners Court, as is set out in Section 87.002 of the Code. The Presiding judge of the early voting ballot board then appoints other members of the board in accordance with the number set by Commissioners Court.

The County Chairs of the political parties submitted lists to the Elections Administration Office of persons who are eligible for appointment as Presiding or Alternate Judges. The Presiding Judge and Alternate Judge must be affiliated or aligned with different political parties (TEC 32.001-32.002). In those lists, they expressed their preference for appointments to the positions of Ballot Board and Central Counting Station Judge and Alternate Judge.
