It is requested that the Commissioners Court conduct a public hearing on Wednesday, April 2, 2025, at 10:00 a.m., to consider installing a stop sign on Heritage Court at the intersection with Heritage Drive, Precinct 1.

BACKGROUND

Citizen inquiry raised concern to Transportation Services that Heritage Court does not have a stop sign at the intersection with Heritage Drive. The County Engineer performed a site visit and recommended that Precinct 1 staff install a stop sign at the location for public safety.

Additionally, the County Engineer recommends that an existing Yield sign at the intersection of Heritage Drive with Burleson Retta Road be replaced with a Stop sign.

There is no fiscal impact associated with this item.

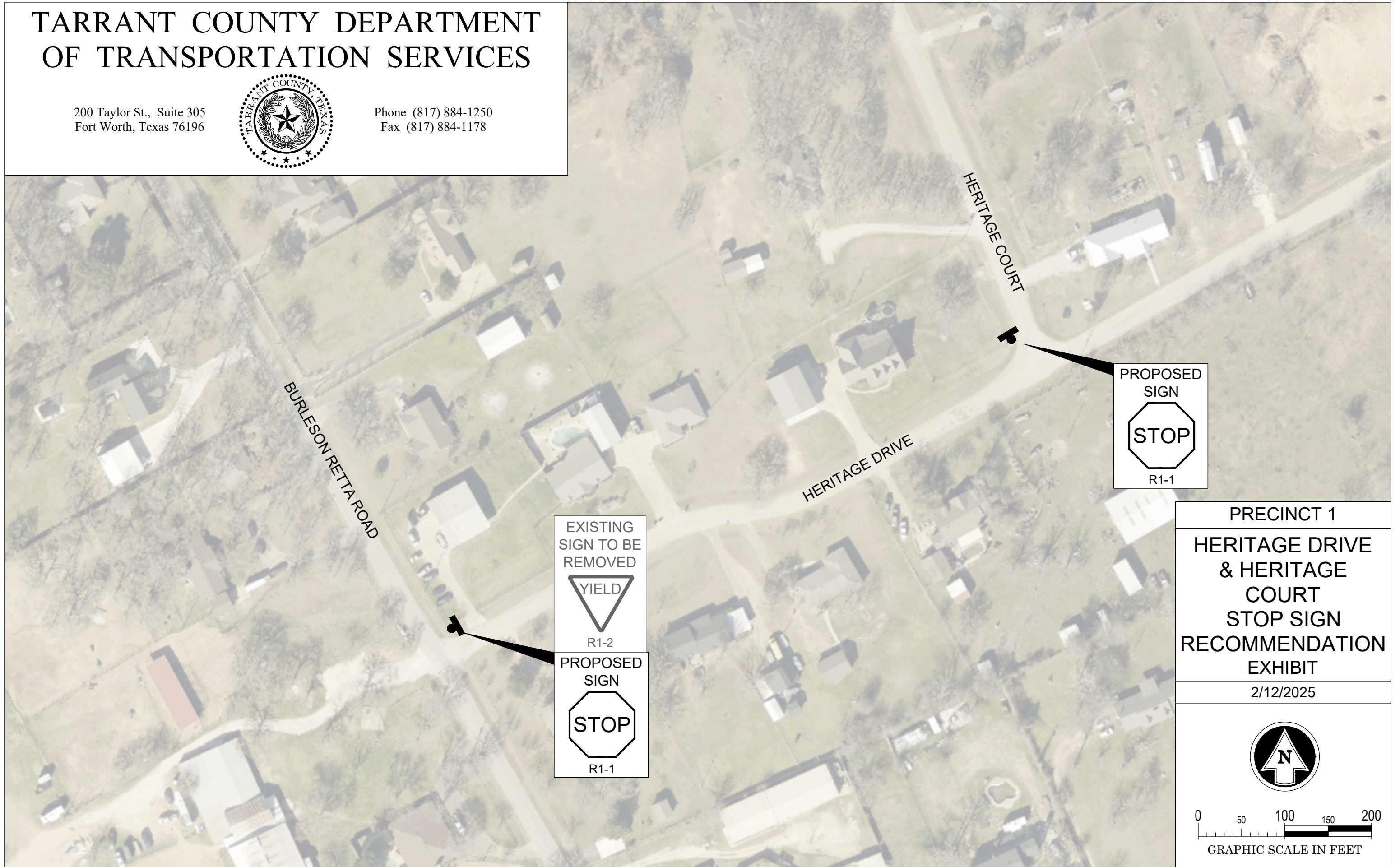

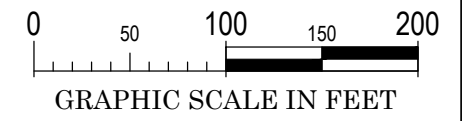
