BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Forty-three (43) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on March 25, 2025 was attended by two (2) vendors as well as representatives from the Sheriff's Office and Purchasing. Seven (7) bids and two (2) no-bids were received.

Bids were evaluated by the Sheriff's Office and Purchasing representatives. Award recommendations are to the high bids meeting specifications.

Response from Kings Firearms LLC deemed non-responsive for failing to agree to pick up awarded lots in person as required.

The purpose of this bid is to sell retired Sheriff's Office SWAT weapons, forfeited weapons and accessories to the highest bidders with current federal firearms licenses.

Therefore, it is the joint recommendation of the Sheriff's Office and Purchasing that Bid No. F2025100, Sale of Weapons, be awarded to the vendors listed above at the per unit price.

FISCAL IMPACT

This award constitutes revenue to Tarrant County in the amount of \$29,948.52. The deposit account is S9600-2025 State Forfeitures/2110710000 State Forfeitures/483012 Auction-Non-Tax.

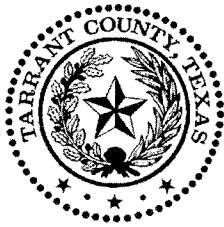
