COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award Bid No. F2025169, Purchase of Boom Mower Accessories, for Precinct 1, to ATMAX Equipment Co. at the per unit price.

BACKGROUND

Notice of the County's intent to bid was advertised in a local newspaper, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Four hundred seventy-seven (477) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. One (1) bid and two (2) no-bids were received.

The low bid received from ATMAX Equipment Co. meets all specifications and is acceptable to Precinct 1.

The purpose of this contract is to purchase attachments such as a quadsaw, grapple, and twinsaw for boom mowers.

Therefore, it is the joint recommendation of Precinct 1 and Purchasing that Bid No. F2025169, Purchase of Boom Mower Accessories, be awarded to ATMAX Equipment Co. at the per unit price.

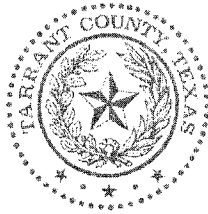
