It is requested that the Commissioners Court award Bid No. F2025067, Annual Contract for Tarrant County Branded Products, Countywide, to the following vendors at the per unit price and discount from list price:

**BACKGROUND**

Notice of the County’s intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Six hundred forty-nine (649) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on January 28, 2025, was attended by twelve (12) vendors as well as representatives from Human Resources, Precinct 2 Maintenance, Criminal District Attorney’s Office, and Purchasing. Twenty-three (23) bids and seven (7) no-bid were received.

Bids were evaluated by Purchasing representatives. Award recommendations are to the low bids meeting specifications.

Bid received from Mastercraft Printed Products & Services was deemed non-responsive as they did not meet specifications for providing imprint fee in their line item pricing.

The term of the contract is twelve (12) months, effective April 15, 2025, with two (2) options for renewal periods of twelve (12) months each.

The purpose of this agreement is to purchase Tarrant County branded products on an as-needed basis throughout the year for the entire County.

Therefore, it is the recommendation of Purchasing that Bid No. F2025067, Annual Contract for Tarrant County Branded Products, be awarded to the vendors listed above at the per unit price and discount from list price.

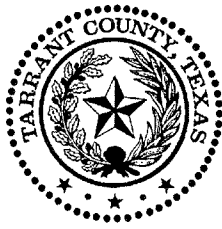
