COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider a Professional Services Contract with Air Balancing Company (ABC) for Testing, Adjusting, and Balancing (TAB) services for the Second Court of Appeals Build-Out on the sixth floor of the Tom Vandergriff Civil Courts Building (TVCCB).

BACKGROUND

On April 28, 2020, the Commissioners Court, through Court Order# 132694, approved a request for qualification (RFQ 2019-225) for HVAC test, adjust, balance, and professional services for various Tarrant County projects granting approval for the Facilities Management Department and Purchasing Department to utilize the selected firms for indefinite quantities of work, as outlined in the RFQ, at the hourly rates in the respective rate schedules for each firm. Firms will be issued a Tarrant County purchase order or will be required to sign a contract for individual projects, depending on the type and cost of the work. ABC was one (1) of the firms that received the highest evaluated ratings from the evaluation committee as having qualifications to meet the County's needs for indefinite quantities of work as outlined in the RFQ.

With approval of this professional services contract, ABC will perform a design review and TAB services for 29,145 square feet on the sixth floor of the TVCCB. The scope of services shall include, but are not limited to the following:

- Pre Demo and Design Review
- TAB Services – Sixth Floor






