COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider acceptance of FY 2025 Texas Nurse-Family Partnership Program Notice of Award (NOA) No. 2025-01 from Texas Health and Human Services (HHS) for the Tarrant County Public Health Department Nurse-Family Partnership (NFP) Program, Contract No. HHS000791900002.

BACKGROUND

Since 2008, Tarrant County has received annual grant funding for the Tarrant County Nurse Family Partnership Program (TCNFP). TCNFP is a voluntary evidence-based home visitation program where highly trained registered nurses work with low-income, first-time mothers during their pregnancy and throughout the first two (2) years of their child’s life. It is the NFP’s goal to improve pregnancy outcomes, child health and development, and family economic self-sufficiency through education and awareness.

On August 24, 2021, the Commissioners Court, through Court Order #136167, approved the FY 2022- 2026 Texas NFP Grant Agreement, Contract No. HHS000791900002, with DFPS for a total not-to-exceed amount of \$6,250,000.00. This agreement serves as the base contract for which annual FY funding may be awarded through NOAs. The FY 2022 budget was \$1,000,000.00. The term of the agreement is from September 1, 2021 through August 31, 2026.

On September 20, 2022, the Commissioners Court, through Court Order #139183, approved FY 2023 Texas NFP NOA No. 2023-01 in the amount of \$1,000,000.00. The funding period for this award is from September 1, 2022 through August 31, 2023.

On August 15, 2023, the Commissioners Court, through Court Order #141474, approved FY 2024 Texas NFP NOA No. 2024-01 in the amount of \$1,072,000.00. The funding period for this award is from September 1, 2023 through August 31, 2024.

With approval of the FY 2025 Texas NFP NOA No. 2025-01, funding in the amount of \$1,072, 406.00 will be awarded. This NOA will allow Tarrant County NFP to continue the services mentioned above during FY 2025. The term for the FY 2025 funding is from September 1, 2024 through August 31, 2025.
