BACKGROUND

On June 20, 2023, the Commissioners Court, through Court Order #141135, awarded RFQ No. 2023-126, Annual Contract for Commercial Real Estate Brokerage Services for Various Projects, for Facilities Management, to the following vendors:

The awards were based upon each vendor’s high ranking in the evaluation procedure as outlined in the RFQ specifications and contained options to renew for two (2) additional twelve (12) month periods.

On May 21, 2024, the Commissioners Court, through Court Order #143173, approved the first renewal option.

This contract provides for professional real estate brokerage services for Tarrant County. The services provided are for undefined projects involving commercial real estate properties located in Tarrant County.

The vendors notified Purchasing in writing that they will extend the same contract terms through July 23, 2026. Facilities Management notified Purchasing in writing that they are pleased with the vendors and want to renew.
