SUBJECT: CONSIDERATION OF A PROPERTY USE AND FEE WAIVER REQUEST FROM SIX FLAGS CHAPTER NATIONAL SOCIETY, DAUGHTERS OF THE AMERICAN REVOLUTION TO USE THE TARRANT COUNTY 1895 COURTHOUSE GROUNDS FOR A FLAG DAY CELEBRATION

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider a request from the Six Flags Chapter National Society, Daughters of the American Revolution (NSDAR) to use the Tarrant County 1895 Courthouse grounds for a Flag Day Celebration on Saturday, June 14, 2025. In addition, Six Flags Chapter NSDAR is requesting all fees be waived.

BACKGROUND

The NSDAR is a non-profit, non-political women’s service organization focused on patriotism, preservation of American history, and educational outreach. The Six Flags Chapter, organized in Benbrook, Texas on February 14, 1929, is based in Fort Worth and named to honor the six (6) countries that governed Texas.

The Flag Day Celebration is a patriotic community event honoring the American Flag. Six Flags Chapter NSDAR is requesting to host this event on Saturday, June 14, 2025, from 9:30-10:00 A.M. at the DAR America Memorial located on the grounds of the 1895 Courthouse. The event will feature a color guard from the Sons of the American Revolution and approximately twenty (20) attendees from three (3) Fort Worth DAR Chapters.

Six Flags Chapter NSDAR has completed the required property use forms.

FISCAL IMPACT

The estimated fiscal impact based on salary average overtime rates for Facilities Management is approximately \$226.00.
