**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court accept a grant award in the amount of \$118,550.00 for additional Grant funds for an additional Housing Choice Voucher Family Self-Sufficiency (FSS) Coordinator position.

**BACKGROUND**

On October 15, 2024, the Commissioners Court, through Court Order #144074, approved the submission to submit an application to the U.S. Department of Housing and Urban Development for Funding for the FY 2024 Family Self-Sufficiency Coordinator Positions.

When the application was originally submitted Tarrant County Housing Assistance Office (TCHAO) had requested four (4) positions. At that time, Housing and Urban Development (HUD) notified that we were only approved for three (3) positions but if additional funds became available, they would review our initial application.

On June 26, 2025, TCHAO was notified that an additional position has been awarded.

If approved by Commissioners Court, TCHAO will have four (4) FSS Coordinators.

**FISCAL IMPACT**

The initial Grant award was for \$355,650.00. The amount of financial assistance for the additional position is \$118,550.00 for a total amount of federal funds awarded in the amount of \$474,200.00 for FY24. No indirect costs are allowed for this grant and no match is required.
