COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of RFP No. F2024122, Annual Contract for Broker of Record, for the first optional twelve (12) month period at the same contract terms.

BACKGROUND

On September 4, 2024, the Commissioners Court, through Court Order #143805, awarded RFP No. F2024122, Annual Contract for Broker of Record, for Budget and Risk Management, to Higginbotham Insurance Agency, Inc.

The award was based upon evaluation criteria set forth in the RFP specifications and contained options to renew for two (2) additional twelve (12) month periods.

The purpose of this contract is to obtain an agent who will advise the County in the evaluation of current County insurance policies, as well as recommend and negotiate rates and terms for potential replacement policies, according to what is in the best interest of the County.

The vendor notified Purchasing in writing that they will extend the same contract terms through September 3, 2026. Budget and Risk Management notified Purchasing in writing that they are pleased with the vendor and wants to renew.

Therefore, it is the joint recommendation of Budget and Risk Management and Purchasing that the Commissioners Court approve renewal of RFP No. F2024122, Annual Contract for Broker of Record, for another twelve (12) month period.

FISCAL IMPACT

Expenses for the last twelve (12) months were \$44,500.00. Funding is available in account 10000-2025 General Fund/1140100000 Non-Departmental/575011 Casualty Insurance.

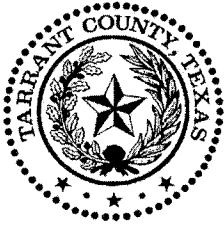
