COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of eCourtDate, Inc. as sole source, for the purchase of Defendant Notification System, for Criminal Courts, Juvenile Services, and County Clerk.

BACKGROUND

On March 8, 2022, the Commissioners Court, through Court Order #137666, approved eCourtDate, Inc. as the sole source for Defendant Notification System.

On March 5, 2024, the Commissioners Court through Court Order #142779, approved the renewal of the sole source.

eCourtDate, Inc. is the current provider of the Defendant Notification System. It provides a notification system to inform defendants of upcoming hearings to help improve the court appearance rate, thereby reducing the community and court costs associated with missed hearings. The solution is cloud-based with a subscription cost model.

eCourtDate, Inc. provided the Purchasing Agent documentation to substantiate that their sole source status has not changed, and their product is manufactured, sold, and distributed exclusively by eCourtDate, Inc. There are no agents or dealers authorized to represent this product.

Under the County Purchasing Act, exemptions to the competitive bidding requirements are allowed for certain types of purchases. The statutes require that the Purchasing Agent advise the Commissioners Court of the existence of only one (1) source, with such notice to be entered into the minutes of the Court.

Accordingly, the above item has been determined to be sole source under the County Purchasing Act 262.024(a) (7) as follows:

- "(7) an item can be obtained from only one source, including:
 - (A) items for which competition is precluded because of the existence of patents, copyrights, secret processes, or monopolies;"
